#### Crime in Tennessee Submission Deadline

It's imperative for your agency to meet the deadline for all data submissions. Any data files—incidents that occurred in 2016, received after March 10, 2017 will not be included in the 2016 Crime in Tennessee Report. If you are unsure about your data submissions, please download your agency's report from TNCRIMEONLINE and review for accuracy. Any issues that are identified by TBI in the annual review that are not explained or corrected by March 10, may result in your agency's page being footnoted in the Crime in Tennessee Report. The finalized report will be posted on sharepoint one week prior to when the report is released to the general public.

# Recent changes to the TNCRIMEONLINE Website

Once you select the blue diamond the feature allows you to display your data differently. Available options may be selected by using the drop down list of options that is displayed in the upper left hand corner.

#### **Location Codes**

An offense location should be reported as descriptively as possible. The location code provides detailed information about an incident and helps establish crime patterns or trends. If the incident occurred in the parking lot of a grocery store, the location would be Parking/Drop Lot/Garage. Now agencies can be even more descriptive with the ability to enter a second location. For example, if the incident occurred in the parking lot of a court house, the 1st location (the primary location) would be Parking/Drop Lot/Garage. The secondary location would be Government/Public Building. Only the primary code will be submitted to the FBI.

Be as specific as you can when entering a location code. If you are not sure, check the TIBRS Manual 13<sup>th</sup> ed., beginning on page 13. If there is still uncertainty, contact your CJIS Support Specialist. Please remember to send the complete narrative.

#### Training Slide of the Month

Group B Incidents will always have 1 arrestee and 1 offense only. If your incident has more than one arrestee for a reportable Group B and no reportable Group A offenses, you must separate your arrestees into their own incident.

# GROUP B INCIDENT DATA If multiple people commit Group B offenses during one "arrest," report them as separate incidents. EXAMPLE During a traffic stop, an officer arrested the driver for DUI. In addition, the passenger was arrested for Underage Consumption. This should be reported to TIBRS as two separate incidents. Once again, the incident numbers must be unique.
