Reporting Prescription Drugs

In the past, the category of Prescription Drugs was only allowed to be reported with Larceny/Theft offenses, Burglary, or Robbery. Now, it can be reported with any offense that can have a stolen property record. TIBRS Fact or Fiction

FICTION:

If victims/offenders/arrestees are full-time students at a college or university, classify them as a Resident. If they are a part-time student, or an employee of the college/university, classify them as a Non-Resident.

FACT:

If victims/offenders/arrestees live on campus (i.e. residence hall, dormitory, etc.), classify them as a Resident (R). If they do not live on campus, classify them as a Non-Resident (NR). It has *nothing* to do with full-time or part-time status. It has *everything* to do with where they reside.

.....

FICTION:

Kidnapping is not reportable unless the victim is held captive for 10 minutes or more.

FACT:

Crimes do not have time limits. Kidnapping/Abduction (100) is defined as "The unlawful seizure, transportation, and/or detention of a person against his/her will, or of a minor without the consent of his/her custodial parent(s) or legal guardian." It is reportable regardless of how long the person is detained by the offender.

FICTION:

Motor Vehicle Theft/Joyriding is not reportable unless the offender has the vehicle in their possession for more than 10 minutes.

FACT:

Once again, crimes do not have time limits. Motor Vehicle Theft (which includes joyriding) is defined as "The theft of a motor vehicle." It is reportable regardless of how long the offender has the vehicle.

.....

FICTION:

If the victim states the offender was a stranger, use the Relationship Unknown code (RU).

FACT:

If the victim states the offender was a stranger, use the Stranger code (ST).

FICTION:

In the property segment, an installed car radio is classified as Vehicle Parts/Accessories, but an uninstalled car radio is classified as Radios/TVs/VCRs.

FACT:

In the property segment, any radio, CD player, etc. that is designed/made for a vehicle should <u>always</u> be classified as Vehicle Parts/Accessories (38), whether it is installed or not. Remember – we are talking about the <u>property category – NOT</u> the offense type. If an <u>installed</u> radio is stolen from a vehicle, the <u>offense</u> is Theft of Motor Vehicle Parts/Accessories (23G), and the <u>property category</u> is Vehicle Parts/Accessories (38). If an <u>uninstalled</u> radio is stolen from the back seat of a vehicle, the <u>offense</u> is Theft From a Vehicle (23F), and the <u>property category</u> is Vehicle Parts/Accessories (38).

.....

FICTION:

Failure to Appear (FTA) warrants that have been served are not reportable if the original offense was a non-reportable offense (i.e., a man failed to appear in court on a Reckless Driving charge.) When the FTA warrant is served, it would not be reportable because Reckless Driving is not reportable to TIBRS.



TIBRS Fact or Fiction (cont.)

FACT:

Failure to Appear is a crime in and of itself and is reportable to TIBRS as All Other Offenses (Group B, 90Z) once the warrant is served, regardless of the original offense.

FICTION:

The property category for vandalized vehicles is Vehicle Parts/Accessories.

FACT:

The property category for a vandalized vehicle is the *vehicle type*. If someone slashes the tires on a pickup truck, the correct property category is Trucks (37). If someone slashes the tires on a motorcycle, the correct property category is Other Motor Vehicles (24), etc.

FICTION:

If a victim does not verbally state "I was in fear" or "I was in reasonable fear", Intimidation is not reportable to TIBRS.

FACT:

Intimidation is defined as "To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack." The victim does not have to verbally state they were in fear, afraid etc. Generally, the fact that they reported it to law enforcement at the very least implies they were afraid of whatever the offender said or did. Example: Victim's ex-husband saw her in a restaurant and said "When you leave here, I'll kill you." She called law enforcement to report it. She told the officer "I think he meant it", but she does not verbally state "I was afraid." The incident is reportable to TIBRS as Intimidation (13C).
