### What Should Agencies Do When There is a RAC Change?

When there are personnel changes that affect TIBRS within your agency, please notify Steven Jancarek of the CSU as soon as possible. Agencies with newly appointed RACs or Alt. RACs should provide the CSU with the following information on agency letterhead:

- First and Last Name of new RAC or Alt RAC
- Date of Appointment
- Driver's License Number
- Contact Phone Number
- E-mail Address



### Auditor's Corner

The regional LEICs utilize the *Auditor's Corner* to share general information as well as specific issues found during audits of Tennessee law enforcement agencies' TIBRS data.

#### No Access to TnCOP or Aventail

Agencies that are having trouble accessing TnCOP and/or logging on to Aventail should notify CSU immediately to assist with resolving the issue. Please do not delay notifying CSU of the problem to avoid falling behind on TIBRS data entry and late submissions of monthly data files.

#### **Detailed Narratives**

The LEICs want to emphasize the importance of detailed narratives when attempting to accurately classify offenses. As mentioned in a previous 2012 newsletter, missing narratives and/ or narratives lacking pertinent information **will** generate a finding (F9) during audits and will count towards the total error count for the agency.

#### Who is the Victim?

During this year's audits, LEICs have found errors in correctly determining the victim types in incidents where an offender breaks into or steals from a business. It has been found that the victim has incorrectly been classified as an *Individual* (the business owner). The correct victim type is *Business*.

#### Arrest Types

When reporting an arrest, please be sure to accurately document the Arrest Type. There are three types of arrest reportable in TIBRS:

- On View—offender arrested at scene without warrant or previous incident
- Taken Into Custody—offender arrested based on warrant for incident that occurred on an earlier date/time
- Summoned/ Cited—offender issued a summons or citation <u>at the scene</u> and released to appear in court

#### Reporting the "Handling" of Juveniles

All TIBRS offenses committed by juveniles (under age 18) **should** be reported even when the juvenile is taken into custody and released

without being charged. Please refer to the TIBRS Data Collection manual for specific instructions concerning the "handling" of juveniles. Two interactions with juveniles that are nonreportable are (1) police contacts with juveniles where no



offense was committed and (2) juveniles taken into custody for their own protection, but no crime committed.

Question:

Lately, I've been receiving calls on the  $6^{th}$  or  $7^{th}$  day of the month to send in my data submission. I thought I had until the  $10^{th}$  of the month to submit my data. Isn't that correct?

#### **Answer:**

Technically, you do have until the 10<sup>th</sup>, but because we are obligated to submit your data to the FBI on time, the sooner you send in your data, the sooner we can send it to the FBI. For TnCOP agencies: Remember, if you are still entering data between the 1<sup>st</sup> and the 10<sup>th</sup>, we will not receive the data until the following month anyway. The contents of the data file are based on date of incident/arrest entered. Agencies using vendors need to check with their vendor support to discover if their files are created with the same parameters.

# TIBRS Q & A



#### Question:

I'm having trouble with an entry in TnCOP. May I give you my password so you can log in as "me" and assist me with the entry?

#### **Answer:**

<u>Absolutely</u>, <u>positively</u>, <u>not</u>. Sorry, but that is something we cannot do. Remember your training! <u>Never</u> share your password with <u>anyone</u>, <u>including members of</u> <u>CSU!</u> We will assist you by logging in as ourselves and searching for your incident number. That way, we can view the incident in question but cannot change it in any way. If the incident has not replicated to the CRMS, we will assist you over the phone.

## How Are We Doing?

We are implementing a new survey tool to ask your opinion of the QAR process, training, and technical assistance visits. Collecting feedback will allow the CSU to assess TIBRS agencies' satisfaction with our various activities. This data collection will be done through a tool called *Survey Monkey*. Each activity will have a specific survey.

You will receive an e-mail with a link inviting you to complete a survey following a QAR, training class or technical assistance visit. You may remain anonymous, but we would appreciate knowing the identity of the rater in case we have any follow-up questions. This should start in late September.

# **New TIBRS Repository**

The new TIBRS repository is in place. All of the agencies using vendor RMS programs received notice of their errors in the new repository during August after we processed July 2012 data files through the test system. One other change that has been implemented involves the submission of Group B Arrests. If you use a vendor RMS, you will now be able to submit multiple individuals under one Group B Arrest number with distinct arrestee sequence numbers for each individual. Please note: If you delete the Group B Arrest – all arrestees will be deleted and you will need to resubmit any that should be included in the incident.

You can also submit Group B arrests now without regard to the original arrest date. This will allow for names to be expunded for Group B Arrests that are older than the current year and one year back.

We are compiling an updated error manual to reflect the changes in the new repository and hope to have it ready in October. Please contact a member of the CSU if you have any questions.
