

Incident Submission Process

Since we are preparing for year-end publications, we want to ensure everyone understands the data submission process. If you use a commercial vendor, your file must be created and submitted to TIBRS no later than the $10^{\rm th}$ of the month. Your file should only

contain data that was entered, edited, modified or deleted during the previous month. For example, your January 2019 submission is created using the time frame of 12/1-12/31,2018. It must be received by TBI no later than the 10th of January. Note: There are no mechanisms that will automatically send your TIBRS DATA submissions to TBI. You are responsible for submitting your agency's data. The publication schedule is listed on the following page. Please contact your auditor if you have questions regarding your data.

1st Quarter, 2019 TIBRS Publication Schedule

DATE	DEADLINE		
Thursday Jan. 10, 2019	Preliminary 2018 data submissions due. This includes <u>all</u> agencies in the state. ALL 2018 incidents must be entered and submitted by this date. If your file includes errors, they should be edited and resubmitted.		
Friday Jan. 18, 2019	Preliminary 2018 Crime on Campus data sent to colleges/universities for agencies to review, verify, and resubmit.		
Friday Jan. 25, 2019	Preliminary 2018 Crime in Tennessee/Hate Crime/LEOKA data sent to agencies to review, verify, and resubmit.		
	FINAL 2018 Crime on Campus corrected data submissions due. All incidents must be edited and resubmitted on or before this date!		
Friday Mar. 8, 2019	2018 Crime on Campus preliminary publication sent to college/university agencies for review.		
Monday Mar. 11, 2019	FINAL 2018 Crime in Tennessee/Hate Crime/LEOKA data submissions all due. All incidents must be edited and resubmitted on or before this date!		
Monday Mar. 18, 2019	2018 Crime on Campus publication release date.

- CrimeInsight class does not count toward initial or recertification training requirements for Reporting Agency Coordinators (RACs) or Alternate RACs. However, due to the many advantages of using CrimeInsight, we highly recommend that RACs and Alt. RACs attend the class if at all possible.
