TCA 55-12-127 - Surrender of license or registration upon revocation, suspension or cancellation Enforcement Officers Violations Penalties.

During a recent audit, it was brought to our attention that on page 129 of the 14th Edition TIBRS Data Collection manual the above TCA code is listed as reportable (90Z - All Other Offenses). This is an error on our part that has now been corrected. TCA 55-12-127 is a traffic offense and is not reportable to TIBRS. The corrected version of the manual is available on the TBI web site. We apologize for any inconvenience or confusion this may have caused.
