Subject: New Weight Limit Posting Bridge **Effective February 7, 2020**  
Bridge Location: I-40 East Bound Mile Marker 194.7, I-40 West Bound Mile Marker 194.8  
I-40 over Harpeth  
Davidson County – City of Nashville  
Date: January 22, 2020

The subject bridge was inspected by TDOT field personnel on November 26, 2018. Through that evaluation and bridge inspection it has been determined to restrict the gross weight limit of 40 tons for all vehicles. This will preclude all overweight, single trip and annual, permit traffic from utilizing this bridge. As such and in accordance with TCA 55-7-205(8)(A) The commissioner has the authority to reduce the maximum gross weight of freight motor vehicles operating over lateral highways and secondary roads where, through weakness of structure in either the surface of or the bridges over the lateral highways or secondary roads, the maximum loads provided by law, in the opinion of the commissioner, injure or damage the roads or bridges.

In accordance with TCA 55-7-205(c) The commissioner shall, at each bridge and on each lateral highway or secondary road, post signs indicating the maximum gross weight permitted thereon, and it is unlawful to operate any freight motor vehicles thereon with a gross weight in excess of the posted weight limit, and any person violating the rules and regulations of the commissioner upon the secondary or lateral roads commits a Class A misdemeanor.

Effective 1/27/20 TDOT Oversize and Overweight office will utilize the established detours for all OS/OW permitted loads. TDOT permit office will also eliminate all envelope routes that contain this bridge replacing them with detour envelope routes. TDOT has developed multiple detours, depending on the direction of travel to accommodate Oversize and Overweight permitted loads. Attached you will find a variety of detours that must be utilized until further notice.
