## PROJECT DESCRIPTION

THIS PROJECT INVOLVES THE CONSTRUCTION OF THE DUNLAP STREETSCAPE PROJECT, PHASE 2. THE PROJECT IS LOCATED IN DUNLAP, TN ALONG CHURCH STREET FROM THE INTERSECTION OF CHURCH STREET AND RANKIN AVENUE TO THE INTERSECTION OF CHURCH STREET AND SPRING STREET AND CONTINUING ALONG SPRING STREET TO ITS INTERSECTION WITH CHERRY STREET / OLD YORK HWY E. THE WORK TO BE COMPLETED CONSISTS OF SIDEWALKS, CURB AND GUTTER, ACCESSIBILITY UPGRADES, LANDSCAPING, SIGNAGE, PEDESTRIAN LIGHTING, AND PEDESTRIAN AMENITIES. THE TOTAL PROJECT LENGTH IS APPROXIMATELY 1,565 LINEAR FEET.
