# **INSTRUCTIONAL BULLETIN NO. 20-03**

### REGARDING CHAPTER 2 - GEOMETRIC DESIGN CRITERIA RELEASE

**Effective immediately,** the Roadway Design Guidelines Chapter 2 has been released. Chapter 2 is not a direct replacement of the previous Roadway Design Guidelines Section 2. This release contains new information and has re-structured the layout of the entire Roadway Design Guidelines. The focus of this chapter is Controlling Geometric Design Criteria, Non-Controlling Geometric Design Criteria, Intersections, Interchanges, Medians, Structural Design Haul Roads, Earthwork Design, Truck Climbing Lanes, Retaining Wall Design, and Roundabout Design. All information located in this new release supersedes any other areas in the Roadway Design Guidelines.

Associated with this instructional bulletin is a CADD update that includes updated forms. The CADD update and revised Roadway Design Guidelines Chapter 2 are available online.
