INSTRUCTIONAL BULLETIN NO. 21-01

REGARDING CHAPTER 5 – RIGHT-OF-WAY RELEASE

Effective immediately, the Roadway Design Guidelines Chapter 5 has been released. This release contains new information and has re-structured the layout of the entire Roadway Design Guidelines. The focus of this chapter is Preparing Right-of-Way Plans, Roadside Design Criteria, Traffic Control Plan Design, Environmental Considerations, Non-Traditional Projects, and Right-of-Way Process. All information located in this new release supersedes any other areas in the Roadway Design Guidelines.

There is a significant change to how Environmental Notes will be required. The Environmental notes in Roadway Design Guidelines Chapter 9 have been moved to have all Environmental Notes listed in Section 4. There are four sub-sections listed for General and Special Environmental Notes and General and Special EPSC Notes. At the ROW Field Review and final ROW plan submittal, there will be a new Environmental Notes sheet that is required. This sheet series will be Sheet 2E series. These notes will come from the sub-sections 1 and 2. The EPSC Notes will still be listed as the first sheet of the EPSC series and will use notes from sub-sections 3 and 4. RDG Chapter 9 has been updated as part of this IB to reflect these changes.

Associated with this instructional bulletin is a CADD update that includes updated forms, updated checklists, updated FileNet Deliverables doc. The CADD update and revised Roadway Design Guidelines Chapter 5 are available online.
