PURPOSE OF POLICY STATEMENT:

The purpose of this policy statement is to provide an overview of the Operational Protocol, its development, and its use.

DISCUSSION:

The first Operational Protocol was completed in 2002 in response to a Special Term and Condition (STC) of the TennCare waiver approved by the Centers for Medicare and Medicaid Services (CMS) that year. It has been updated every year since then. TennCare's policy is to update the Operational Protocol any time there is a change in the program, but at least annually.

When the Centers for Medicare and Medicaid Services (CMS) approved the extension of TennCare II in October 2007, the requirement that the Bureau maintain an Operational Protocol was removed. However, because the Operational Protocol has been useful in providing a general introduction to the TennCare program and an overview of various components of the program, the Bureau decided to continue the Operational Protocol and update it as necessary. In accordance with the Schedule of Deliverables outlined in the TennCare II waiver, TennCare must send a copy of the Operational Protocol to CMS each time it is updated.¹

The Operational Protocol is divided into seven chapters:

- Chapter 1 Overview
- Chapter 2 Eligibility and Enrollment
- Chapter 3 Benefits and Cost Sharing
- Chapter 4 Service Delivery
- Chapter 5 Quality of Care
- Chapter 6 Administration
- Chapter 7 Program Integrity
