

Letter of Intent: Achievement School District Charter School applying to Tennessee Public Charter School Commission

Any eligible Achievement School District (ASD) charter school operator intending to apply for authorization by the Tennessee Public Charter School Commission (Charter Commission) must file a Letter of Intent to the Charter Commission by October 15th of the school year prior to the school year the charter school would operate under the Charter Commission. This letter must be delivered to the Charter Commission and the Tennessee Department of Education no later than **October 15th** at 11:59p.m. Central Time. When the October 15th deadline falls on a Saturday, Sunday, or State observed holiday, the letter of intent is due on the next business day.

Submit the letter of intent via email to the Charter Commission at CharterSchool.Appeals@tn.gov and Tennessee Department of Education at charter.schools@tn.gov.

An application fee of \$2,500 must be submitted by **November 15th**. Checks or money orders should be made out to the State of Tennessee–Tennessee Public Charter School Commission. Please mail the check or money order via USPS with attention to Maggie Lund to the Charter Commission's address: Davy Crockett Tower, 8th Floor, 500 James Robertson Parkway, Nashville TN 37243. We also recommend requesting tracking information as additional assurance. Once received, the Charter Commission will follow up to confirm receipt of the fee. Failure to submit the application fee will result in the application not being accepted by the Charter Commission.
