# 1 big thing: VA is processing PACT Act claims for terminally ill Veterans.

**VA began processing PACT Act claims for terminally ill Veterans yesterday** – December 12<sup>th</sup>. VA made this announcement in a <u>press release</u>.

**What next:** Don't wait to file PACT Act related claims. VA has been doing development and is prepared to begin processing <u>all PACT Act claims</u> January 1<sup>st</sup>.

If you've filed a PACT Act claim for a terminally ill Veteran, check VBMS to ensure the Veteran's profile has the "terminally ill" flash.

**By the numbers:** Veterans have filed over 679,584 claims since the PACT Act was signed on August 10<sup>th</sup>. This is an increase of over 17% from the same period last year.

Through the week ending December 10<sup>th</sup>, VA has received the following –

- 185,819 PACT Act related claims received since August 10<sup>th</sup>
- 5,126 PACT Act claims received in Tennessee

### What's new:

- The Board of Veterans' Appeals (BVA) can and has been granting benefits based on the PACT Act. BVA follows current law and is not waiting until January to implement the expansion of benefits provided by the PACT Act.
- There's been an increase in email, phone and social media scams targeting Veterans alleging to help them access PACT Act benefits. This <u>VA Fact Sheet</u> added to TDVS's Pact Act Toolbox -- outlines some Do's and Don'ts for Veterans.

### VALife – VA's New Whole Life Insurance Program

## **Enrollment opens January 1, 2023,** for VA's new life insurance program – VALife.

VA offers life insurance options for Veterans, service members and family members. VALife is a new program that offers whole life coverage for service-connected Veterans. This <u>VA</u> <u>Fact Sheet</u> offers important milestones for the programs roll out and how VALife impacts VA's Service-Disabled Veterans Insurance (S-DVI) program.

### Veterans Can Get Free Lifetime Passes to National Parks and Other Public Lands

**The National Park Service** unveiled a lifetime pass that provides free access to National Parks for Veterans.

- Who is eligible: Current service members and their dependents, Veterans and Gold Star Families.
- Where does it apply: Waives entrance fees for the National Park Service and U.S. Fish and Wildlife Service and standard amenity recreation fees for the Bureau of Land Management, Bureau of Reclamation, U.S. Forest Service and U.S. Army Corps of Engineers sites.

**Don't forget – the Survivor Benefit Plan (SBP) offset ends in 2023.** On February 1, 2023, surviving spouses will receive both their full SBP payment and Dependency and Indemnity Compensation (DIC) payment from VA.
