- Next PACT Act Deadline Health Care Thanks to the PACT Act, many Veterans are now
  able to enroll directly in VA health care without first applying for VA benefits but for



some, the time to apply is running out. There are two related groups with different deadlines, as described below.

- 1st Veterans who deployed to a combat zone, never enrolled in VA health care, and left active duty after September 11, 2001, and before October 1, 2013, are eligible to enroll directly in VA health care without first applying for disability compensation benefits. Their deadline to apply is September 30, 2023.
- 2<sup>nd</sup> Veterans who deployed to a combat zone, never enrolled in VA health care, and left active duty on or <u>after</u> October 1, 2013, are eligible to enroll directly in VA health care without first applying for disability compensation benefits. Their deadline to apply is 10 years after they left active duty, meaning some Veterans' eligibility could end as early as October 1, 2023

## **VA and Veteran Benefit Updates**

VA to Review Connections Between Toxic Exposure and More Cancers

VA will review possible connections between toxic exposures and acute leukemia, chronic leukemia, and multiple myeloma. VA plans to assess the scientific literature and historical claims data to see if there is a relationship between them and toxic exposures.

**Why it matters:** This review will help VA determine whether these conditions become presumptive in the future. It also matters because it will use the new process for establishing presumptive conditions, which was part of the PACT Act.

### **VA Expands Breast Cancer Screenings**

Veterans under 40 that may have been exposed to burn pits and other toxins are now eligible for breast cancer risk assessments and mammograms at VA.

**Who does this help:** These services are available to Veterans who served in the following places and timeframes regardless of VA health care enrollment status:



- Iraq between Aug. 2, 1990, and Feb. 28, 1991, and from March 19, 2003, until VA determines burn pits are no longer used in Iraq.
- The Southwest Asia theater of operations, including Kuwait, Saudi Arabia, Oman, and Qatar (but not including Iraq), from Aug. 2, 1990, until VA determines burn pits are no longer used in such locations.
- Afghanistan, Djibouti, Syria, Jordan, Egypt, Lebanon, and Yemen from Sept. 11, 2001, until VA determines burn pits are no longer used in such locations.
- Other locations and time periods as determined by the Airborne Hazards and Open Burn Pit Registry.



## **TDVS Quality Review**

**As part of the Golden 24 initiative**, forms and documents are being filed with VA within one business day 98-99% of the time. A small % are returned to the VSO/CSO for correction before filing.



#### What's new:

- VSOs/CSOs can now file POA and ITF using VetraSpec filing tools.
- TDVS continues to provide quality review of packaged forms and documents. However, it's based on more <u>objective standards</u>.

## Why it matters:

- VSOs/CSOs can gain immediate access to a Veteran's record using VetraSpec filing tools.
- Forms and documents are getting to VA faster ensuring TDVS doesn't contribute to decision wait times.
- As some filing shifts to VSOs/CSOs, the Local Appeals Team is gaining capacity to provide more oral and written advocacy in support of appeal resolution and timeliness.

## **Advocate Spotlight**

**Veteran advocacy comes in all shapes and sizes.** The work of a VSO certainly involves a lot more than just filing claims. Here's a great example.

**Give me the background:** A faith-based organization connected with a TDVS field office offering assistance to Veterans that needed help with chores or small projects around the



house. A few weeks later, a Veteran sought the assistance of the field office in finding a resource to help with fence repair following storm damage. The organization fixed the fence free of charge.

**What a win:** The success put a big smile on the TDVS team members face. We hope it puts a smile on yours as well as you recall your "wins" and advocacy that didn't involve a VA claim.
