#### Automated Decision Support Background

- VBA has prioritized the leveraging of available technology to automate specific areas of development.
- The goal of Automated Decision Support is to improve timeliness and efficiency and prevent future backlogs in claims processing.
- Technology, data and employee feedback was leveraged to automate administrative tasks and reduce burden for VBA employees.
- Automated Decision Support will result in:
  - ✓ Faster more accurate and consistent decisions
  - Creating a better user experience for processors
  - ✓ Enhanced customer experience for Veteran's and their beneficiaries







### **Automated Decision Support- Definitions**

- All Automated Eligible Claims: all contentions on the claim are eligible for automation
- Multi-Issue Claims: one or more automation eligible contentions AND one or more non-automation eligible contentions
  - Controlled by diagnostic codes: automation controls which automation eligible contentions can be processed as multi-issue
  - At least one of the contentions must be rhinitis, sinusitis, and/or asthma
- Automated Review Summary Document: decision support document in the Veteran's e-Folder, documenting military service, relevant medical evidence, other medical evidence, and rating schedule
- **Draft Exam:** examination is drafted, as there are multiple non-automated contentions requiring review









#### **Ready for Decision and Automated Exam Functionality**

#### **Ready for Decision**

- Medical evidence related to claimed conditions will be identified and compiled from Veterans' electronic health records
- Medical evidence within Veterans' VBMS eFolders will be identified and compiled
- Military service and medical evidence necessary to decide the claim will be intelligently indexed within the Automated Review Summary Document (ARSD)
- The ARSD will enable RVSRs to complete more decisions based on available evidence.

#### **Automated Examinations**

- When there is not enough medical evidence to decide the claim, an automated examination request will be submitted through the VBMS Exam Management System
- Automated Review Summary Documents (ARSDs) will be associated with Veterans' VBMS eFolders to allow examiners to quickly identify and review evidence relevant to the examination

## User Role Responsibility

- ADS assists claims processors in making fast, accurate, and consistent decisions for Veterans. VSOs can expect to begin seeing the ARSD in the eFolder and draft examinations generated for eligible claims.
- > ADS plays a role for each VBA employees processing claims:
  - Veterans Service Representative: VSRs may see draft examinations in VBMS and are required to take the appropriate steps in ordering an exam. VSRs are responsible for confirming if an ADS claim is RFD if additional development actions are required
  - Rating Veterans Service Representative: RVSRs are responsible for reviewing relevant evidence and making a decision on the Veterans claim. RVSRs can utilize the ARSD as a decision support tool to assist with quickly identifying evidence and locating key terms to help in their decision.
  - □ **Quality Review Specialist:** The QRS will begin seeing Individual Quality Reviews for claims impacted by automation. They should continue following current review policies and procedures for these claims. There is a separate quality team that deals with reviewing automation system actions that will have no impact to an individual user.


### Automated Decision Support Training Plan

- Helpful Tips and Tricks/Resources



- The ARSD supports identifying possible military service related to presumptive conditions (if applicable to the contention) and possible evaluation criteria

#### Automated Review Summary Document

- The ARSD extracts relevant key data terms from specific document types within the eFolder and the Veteran's electronic health record (EHR) to provide a summary of findings and relevant information for the claims processor to review
- The ARSD will only list automation-eligible contentions.



#### User Interface Enhancements - Contention Lifecycle Status:

This screen includes a new attribute called the contention lifecycle status. This is similar to the claim lifecycle status, the values are similar as contentions work through the same process as a claim as a whole. The vast majority of the time, the contention lifecycle status will exactly match the claim lifecycle status. However, when partial ratings are authorized, the contentions that were part of the partial rating will move to a "closed" status. This is intentional, so users processing contentions after the continued at authorization will be able to easily see on the contention screen which contentions have already been addressed, and which one are still remaining.

#### User Interface Enhancements - Contention History Screen:

Users will also be able to see a new contention history screen. The system now captures and the user is able to view the history of actions taken on claims at the contention level. This indicates whether the contention has utilized automated processing. This capability allows claims processors to make informed decisions on the claims and will allow more efficient workload management. In this space users can identify what actions were taken by automation as well as those actions taken by claims processors.

- If you have access to VBMS, you may see the ARSD within certain Veteran eFolders.
- You can view the ARSD to review what evidence the automated technology located and presented to VBA claims processors.
- The ARSD may serve as a time savings to you, as a VSO, if you are attempting to locate specific medical or military service information within the Veteran's VBMS eFolder.
