The duties of the Elevator Safety Board include: licensing elevator inspectors; consulting with engineering authorities and organizations studying and developing safety codes; and determining what rules and regulations governing elevators, dumbwaiters, escalators, aerial passenger tramways and moving walks are adequate, reasonable and necessary to provide for the safety of life, limb and property, and to protect the public welfare.
