High-Demand/High-Pay Occupations In Tennessee

The estimates for wage and salary workers on the table on Page 2 are from the Occupational Employment Statistics (OES) survey, a federal-state cooperative program between the Bureau of Labor Statistics (BLS) and the Tennessee Department of Labor and Workforce Development. The OES survey is an ongoing federal-state survey that collects data from a random sample of one-third of Tennessee employers. Conducted by each state, the OES survey provides national, state, and metropolitan area estimates of employment and wages for 22 major occupational groups and 801 detailed occupations, as defined by the Standard Occupational Classification system.

Page 2 details wage data released in May 2006 for wages beginning in November 2005.

Choosing Occupations

The table was constructed by sorting the wages by metropolitan statistical areas (MSAs). The major occupational groups were then eliminated, leaving only the detailed occupations. Each MSA was sorted by employment, with only the top 20 occupations remaining. The top 20 occupations were then sorted by mean wages (either hourly or annual) with a sample from each MSA listed. This was necessitated by spatial concerns.

The goal was to find the occupations with the most employment that offered the highest wages.

The Results

In each of the metro areas, General and Operations Managers was the highestpaving, high-demand occupation. While it did not have the most employment in all of the areas, it did have the highest pay. Memphis' annual mean for this occupation was \$91,420 (the highest), while Clarksville's was \$60,346 (the lowest). Registered Nurses was listed in eight of the 10 MSAs (except Jackson and Johnson City). Nashville had the highest pay for Registered Nurses (\$57,573), while Morristown had the lowest pay (39,264). First-Line Supervisors/ Managers and Administrative Support Workers was listed on eight of the 10 MSAs, while First-Line Supervisors/Managers of Retail Sales Workers was listed on six of the 10 MSAs. Both of these supervisory occupations was listed as a toppaying job in Jackson, Johnson City, Knoxville, Memphis, and Nashville.

Interestingly, the following occupations are only in one metro area. They include First-Line Supervisors/ managers of Production and **Operations Workers** (Morristown only), Team Assemblers (Nashville only), **Business Operations Special**ists, All Other (Chattanooga only). Executive Secretaries and Administrative Assistants (Memphis only), and Inspectors/Testers/Sorters/ Samplers/ Weighers (Kingsport-Bristol only).

More Data

On Page 2, the data for each occupation include employment numbers as well as yearly and hourly wages, yearly and hourly entry-level wages, and wage ranges. The wage ranges show the median (midpoint) as well as the 25 percent and 75 percent quartiles.

The entire database of 2006 occupational wage data (annual average 2005 wages) for Tennessee is available on two Web sites. 






Unemployment Rates 1976-2005





NONFARM EMPLOYMENT AND LABOR FORCE IN TENNESSEE

Tennessee's seasonally adjusted estimated unemployment rate for April was 5.4 percent, up 0.3 percent from the March rate. This is the 21st consecutive month that the rate is above the national average.

The United States' unemployment rate was 4.7 percent in April 2006. In April 2005, the national unemployment rate was 5.1 percent, and the state's unemployment rate was 5.6 percent.

Across Tennessee, the not seasonally adjusted unemployment rate decreased in 63 counties, increased in 16 counties, and remained the same in 16 counties. The lowest rate occurred in Williamson County at 3.2 percent, down 0.1 percent from the previous month. The highest rate was Clay County's 12.1 percent, down from 13.4 percent in March 2006.

Total nonfarm employment increased by 34,100 jobs from April 2005 to April 2006. During this period, there were increases in accommodation/food services (up 7,300 jobs), which includes an increase of 6,000 jobs in food services/drinking places and 1,300 jobs in accommodation; retail trade (up 7,000 jobs), which includes an increase of 3,100 jobs in general merchandise stores, 1,300 jobs in both building material/garden equipment/supplies and health/personal care stores, and 1,200 jobs in motor vehicle/parts dealers; health care/social assistance (up 5,400 jobs), which includes an increase of 3,000 jobs in ambulatory health care services and 2,000 jobs in hospitals; professional/business services (up 4,400 jobs), which includes an increase of 3,000 jobs in professional/ scientific/technical services; construction (up 3,600 jobs); local government (up 3,200 jobs); wholesale trade (up 2,000 jobs), which includes an increase of 1,300 jobs in durable goods merchant wholesalers; and arts/ entertainment/recreation (up 1,900 jobs). This was partially offset by declines of 1,300 jobs in computer/electronic product manufacturing and 1,200 jobs in food/beverage stores. During April, nonfarm employment increased by 29,500 jobs. There were seasonal increases in accommodation/food services (up 6,900 jobs), which includes an increase of 4,300 jobs in food services/drinking places and 2,600 jobs in accommodation; arts/entertainment/recreation (up 4,900 jobs); professional/ business services (up 3,600 jobs), which includes an increase of 2,400 jobs in administrative/support/waste management ; educational/health services (up 2,900 jobs), which includes an increase of 1,800 jobs in health care/social assistance; construction (up 2,900 jobs); and retail trade and state government (both up 1,600 jobs).


The data from all the nonfarm employment estimates tables include all full- and part-time nonfarm wage and salary employees who worked during or received pay for any part of the pay period that includes the 12th of the month. This is a count of jobs by place of work. Agricultural workers, proprietors, self-employed persons, workers in private households, and unpaid family workers are excluded. These numbers may not add due to rounding. Data are based on the 2005 benchmark.

Total nonfarm employment increased by 1,400 jobs from March 2006 to April 2006. There were seasonal increases in leisure/hospitality (up 800 jobs), which includes an increase of 300 jobs in accommodation/food services; and educational/health services and administrative/support/waste management (both up 200 jobs).

During the past 12 months, nonfarm employment increased by 2,700 jobs. During that time, goods-producing jobs declined by 100, and service-providing jobs increased by 2,800.



There were seasonal increases in professional/business services (up 800 jobs), which includes 700 jobs in administrative/support/waste management; leisure/hospitality (up 600 jobs), which includes 400 jobs in accommodation/food services; and educational/health services (up 200 jobs). This was partially offset by a decline of 200 jobs in nondurable goods manufacturing.



Total nonfarm employment increased by 4,100 jobs from March 2006 to April 2006. There were seasonal increases in leisure/hospitality (up 2,000 jobs), which includes an increase of 1,400 jobs in accommodation/food services; administrative/ support/waste management (up 800 jobs); natural resources/mining/construction (up 400 jobs); educational/health services (up 300 jobs); and durable goods manufacturing and retail trade (both up 200 jobs). This was partially offset by a decline of 300 jobs in local government.

During the last 12 months, there was an increase of 8,800 jobs. During that time, goods-producing declined by 200, and service-providing jobs increased by 9,000.




