## Per Capita personal Income in Tennessee and Counties, 1997 to 2001

In Tennessee, the per capita personal income in 2001 was \$26,808, up 2.0 percent from the previous year.

Per capita personal income is the annual total personal income of residents divided by the resident population as of July 1. Personal income is derived by summing the net earnings by 'place of residence', person's rental income, personal dividend and interest income, and transfer payments. Personal income is measured prior to deductions of income tax and other personal taxes and is reported in current dollars.

In 2001, the counties with the highest per capita personal income were Williamson (\$41,524), Davidson (\$36,394), Shelby (\$32,420), Hamilton (\$30,130), Knox (\$29,426), Anderson (\$27,194), and Wilson (\$27,089). The remaining 88 counties were all below the state average. The lowest counties were Lake (\$13,306), Hancock (\$13,418), Johnson (\$14,463), Union (\$15,178), Wayne (\$15,357), Lauderdale (\$15,522), and Hardeman (\$15,721). Of these only Union and Lake counties had higher per capita incomes in 2001.

The counties with the highest per capita personal income growth rate were Grundy (up 9.2 percent or \$1,688), Van Buren (up 6.1 percent or \$1,020), Monroe (up 4.9 percent or \$860), Carter (up 4.5 percent or \$818), and Morgan (up 4.5 percent or \$687).

The counties with the largest percent decline in per capita income were Pickett (down 6.3 percent or \$1,190), Lauderdale (down 5.3 percent or \$873), Benton (down 3.3 percent or \$681), and Hardeman (down 3.2 percent or \$526).

## IN THE LAST FIVE YEARS . . .

During the past five years, the counties with the highest increase in per capita personal income were Van Buren (up 31.7 percent), Grundy (up 25.4 percent), Davidson (up 24.7 percent), Greene (up 23.9 percent), Cheatham (up 22.0 percent), Cannon (20.8 percent), Shelby (20.6 percent), and Chester (20.5 percent).

The eight counties listed above with the highest percent growth in the last five years consist of five counties in the newly defined metropolitan areas (as of the 2000 Census). One county was a new micropolitan area, and two were rural counties. Also five of the eight counties are in middle Tennessee.

There was one county whose per capita income actually declined in the last five years. Lauderdale County declined 2.7 percent. Other counties with a low percent growth in per capita income include Hardeman (up 5.6 percent), Wayne (up 6.8 percent), Hancock (up 7.2 percent), Hickman (up 7.8 percent), Pickett (up 8.0 percent), Henderson (up 8.1 percent), and Haywood (up 8.4 percent).

The eight counties (listed above) with the lowest percent growth in the last five years are all nonmetropolitan or nonsuburban counties. Five of these counties are in west Tennessee.







#### NONFARM EMPLOYMENT AND LABOR-FORCE IN TENNESSEE

Tennessee's seasonally adjusted estimated unemployment rate for July 2003 was 5.0 percent, down three-tenths of a percentage point from the June 2003 rate. This is the 31st consecutive month that the Tennessee unemployment rate was lower than the national rate.

The United States estimated unemployment rate was 6.2 percent in July 2003. In July 2002, the national unemployment rate was 5.8 percent, and the state unemployment rate was 5.1 percent.

Across Tennessee, the unemployment rate decreased in 49 counties, increased in 43 counties, and remained the same in three counties. The lowest rate occurred in Williamson County at 2.6 percent, down 0.4 percentage points from the previous month. The highest rate was Clay County's 18.6 percent, up from 13.1 percent in June 2003. 

Total nonfarm employment decreased by 600 jobs from July 2002 to July 2003. During this period there were seasonal decreases in transportation/warehousing (down 5,500 jobs), which includes a decline of 2,900 jobs in truck transportation; construction (down 4,600 jobs), which includes a decline of 2,700 jobs in specialty trade contractors; machinery manufacturing (down 3,900 jobs); accommodation (down 1,600 jobs); and apparel and plastics/rubber products manufacturing (both down 1,500 jobs). Over the year, the largest job increases occurred in administrative/support/waste management (up 5,000 jobs), ambulatory health care services (up 3,600 jobs), hospitals (up 3,500 jobs), nursing/ residential care facilities (up 2,200 jobs), local government (up 1,900 jobs), and wholesale trade (up 1,600 jobs).

During the past month, nonfarm employment decreased by 15,300 jobs. There were seasonal declines in local government (down 12,400), which includes a decline of 10,200 in local government educational services; federal government (down 1,500 jobs); transportation equipment manufacturing and state government educational services (both down 1,200 jobs); and professional/ business services (down 1,100 jobs). This was partially offset by increases of 2,100 jobs in health care/social assistance, 1,600 jobs in clothing/clothing accessories stores, and 1,200 jobs in wholesale trade.



During the past 12 months total employment decreased by 400 jobs. During that time goodsproducing jobs decreased by 1,700 while service-providing jobs increased by 1,300.




