Subject: Income Guidelines For Persons Defined As "Low Income Individuals."

Topic: Health and Human Services (HHS) Poverty Guidelines 2016 and the Department of Labor (DOL) Lower Living Standard Income Levels

(LLSIL). To provide Local Workforce Development Areas (LWDAs) with an income guideline table containing calculated poverty levels provided by

HHS and Metro and non-Metro LLSIL for the Southern region.

References: The Workforce Innovation and Opportunity Act (WIOA) defines the term

> "Low-Income Individual" as one who has a barrier to employment and who is in a family with a total family income that does not exceed the higher of the poverty line or 70 percent of the LLSIL. Attached is a table containing the annual LLSIL for 2016 and the HHS poverty guidelines. "LLSIL is used for several purposes under the WIOA. Specifically, WIOA SEC.3 (36)

(A)(B) defines the term "low income individual" for eligibility purposes, and SEC.127(b)(2)(c), SEC.132(b)(1)(B)(IV),(V)(bb) define the terms "disadvantaged youth" and "disadvantaged adult" in terms of the poverty line or LLSIL for State formula allotments. The governor and state/local workforce development boards (WDs) use the LLSIL for determining eligibility for youth and adults for certain services. ETA encourages governors and State/local boards to consult the WIOA regulations and the preamble to the WIOA Final Rule for more specific guidance in applying LLSIL to program requirements" (Federal Register, Vol. 81, No. 58, 16217-16218). The HHS 2016 poverty guidelines may be

percent Metro and non-Metro LLSIL for 2016. To use this table, compare the poverty level for the family size against either the Metro or non-Metro LLSIL, depending on the county of residence, using the higher of the two in

order to qualify the participant as disadvantaged under WIOA.
