*Student Recognition Program for Tennessee Career and Technical Education
Nontraditional Program of Study Career Training*

\$500 Tuition/Postsecondary Expense Reimbursement

The Division of Postsecondary Access and Success/CTE is accepting nominations for the Tennessee CTE Breaking Traditions Award Program to recognize **outstanding** students completing a CTE program area.

The Breaking Traditions Award is an excellent opportunity for CTE students and schools to receive recognition and positive publicity. It acknowledges and highlights CTE student achievement in nontraditional career training and identifies role models for other students considering nontraditional careers.

2011 Award Instructions

ELIGIBILITY:

To qualify for consideration, a student must:

- Be a 12th grade student enrolled in a Tennessee public high school CTE Program during the 2010-2011 school year.
- Be **completing** a state-approved CTE Program that is nontraditional for his or her gender during the 2010-2011 school year (see attached reference list for eligible program areas pages 5&6).
- Be nominated by an instructor, teacher, counselor, administrator, faculty, or other personnel employed by the student's career center or public educational institution.
- Have a satisfactory academic standing (minimum: 3.0 program average, 2.5 cumulative GPA), and an acceptable citizenship and disciplinary history.
- Have made an **outstanding contribution** to the awareness of nontraditional careers through successful participation in one or more of the following activities:
 - Exemplary progress in a CTE program considered nontraditional for the student's gender (skill development, teamwork skills, responsibility, etc).
 - Successful competition in a program-related event or contest (local, regional, state, or national) validating skill development and/or workplace skills.
 - Leadership in a CTE Student Organization (HOSA, DECA, FFA, FBLA, FCCLA, TSA, SkillsUSA) at the local, state, or national level.
 - Actively involved in recruiting other nontraditional students into their CTE program.
 - Mentoring of other students in nontraditional programs.

- Significant contributions to the student's specific CTE program.

TO BE CONSIDERED, A STUDENT MUST:

- Complete all items included in the application **and**
 - Be nominated by a teacher, instructor, counselor, faculty, administrator, or other personnel employed by his or her career center school.
 - Include at least four digital pictures or photographs (see specific requirements below).
 - Include two letters of support for the application from someone other than the nominator.
 - Include the signed release of information/consent statement (also signed by his/her parent/guardian).
 - Have the nominator send the completed application packet to the Division of Postsecondary Access and Success/CTE **postmarked** by **May 1, 2011**.

NOMINATIONS:

Each school may nominate **only one** student per program area. Only school officials may nominate students for this award. *If a nominator feels there are two or more deserving students, the nominator should have the students fill out the awards application materials and have appropriate local school personnel select which student to nominate.*

2011 AWARD CATEGORIES:

- Breaking Traditions Recognition Award (up to \$500 in postsecondary expense reimbursement)
 - Two awards statewide (one male and one female)
- Breaking Traditions Certificate Award
 - Top 10 awards statewide

JUDGING:

A committee composed of CTE consultants will evaluate all complete applications using a 100-point scale. The winners will be selected based upon the information provided in the application, technical skill level, and the ability to be a nontraditional role model for other students. Winners will be notified through their nominators. All decisions will be final, and all applications become the property of the Office of CTE.

TUITION/POSTSECONDARY REIMBURSEMENT:

Payment of the Tuition/Postsecondary Scholarship funds will be made to the student's account directly to the postsecondary institution in which the student enrolls. To receive up to \$500 in postsecondary expense reimbursement, send the postsecondary enrollment information/documentation—invoice/receipt for postsecondary payment (tuition, textbooks, supplies, etc.) to:

APPLICATION REVIEW CRITERIA:

Important: There have been changes to the programs determining the eligibility of students for the Breaking Traditions Award. Please refer to pages 5-7 for the updated information on eligible programs.

Part 1: Nominator Form (pp. 7 & 8, including nominator questions, p. 9)

Must be typed (computer or typewriter). All information must be provided. Nominator and administrator must sign, and nominator's questions must be completed. **(10 points)**

Part 2: Photos:

Photographs must be included for the nomination packet to be complete. **Digital photo files must be submitted.** Please include one head shot and at least three action shots of the student working in his/her program area. (Example: welder welding, brick mason laying brick, nurse caring for a patient, etc.) Please take care when taking/selecting photos to assure that:

1. The student is recognizable as a person of her or his gender.
2. All required safety precautions are in place.
3. It is obvious what the student is doing.
4. Other persons in photo, if any, are not recognizable and identifiable, or photo release is supplied.

The best pictures appear spontaneous with the subject seemingly unaware that the photo is being taken. More than four photos may be submitted if desired. The best four, as determined by CTE staff, will be used for scoring the application. **(10 points)**

Digital Photos: save in **JPEG format**. Select the highest quality available on your digital camera. (A setting of 300 dots per inch, dpi, is needed for publication purposes.) You may submit the photo files as an e-mail attachment or on disk/CD. Please indicate the name of the student and school on disks, CDs, or e-mail files. Please also print out all digital photos and attach them to the nomination packet.

Part 3: Student Form (begins on p. 10):

All questions must be answered. All information must be typed (computer or typewriter) and complete, including required signatures. All pages must be submitted to the nominator.

- A. **Basic information**—Includes contact and program information. **(10 points)**
- B. **Consent/release of information statements signed by parent/guardian.** This signed consent grants permission for the student's image or photographs to be used to promote career training that is nontraditional for his/her gender in print or other media by the Tennessee Career and Technical Division or its designees. This consent also authorizes release of information to local and state press/media should the student be recognized. All nominees will need parents/guardians signature on the form. **(10 points.)**
- C. **Student's Essay (500 or fewer words, p. 11)**—The student should provide basic information about his/her choice of career training, future plans, and school activities. This is the opportunity for

students to put into writing their feelings about exploring the benefits of developing skills in a nontraditional career field. **(40 points)**

- D. **Letters of recommendation (see also page 12)** —From two persons other than the nominator, who know the student well and can address his/her personal/technical strengths (instructor, principal, counselor, mentor, employer, etc.). Must be on the author's official letterhead. **(20 points each)**

(The application will be judged on the content. Students may receive assistance in the editing of the questions and essay, but the information and ideas should be the student's own.)

Nomination Packet:

Please make additional copies of the forms as you need them. All application materials must be typed (computer or typewriter). **All items should be collected and submitted in one packet by the nominator.** Keep a copy for your records.

Packet must include:

- Completed nominator form and questions
- Photos
- Completed student form and essay
- Two letters of support
- Signed Consent Statement

NONTRADITIONAL STUDENTS/PROGRAMS

Nontraditional students are defined as those persons studying careers traditionally chosen by the other gender. A nontraditional program area is one in which 75 percent or more of the persons in that field of work are usually of one gender.

Please Note: There are changes in the Breaking Traditions categories this year. The categories have been aligned to the programs of study and to the list of Nontraditional Courses used to define (for Perkins reporting) nontraditional participants and concentrators for the 2010-2011 school year posted on the following CTE Web page: <http://state.tn.us/education/cte/ad/perkins/index.shtml>. Programs of Study that contain two or more nontraditional courses in that program of study are considered nontraditional for the purpose of the Breaking Traditions Award this year. Data are based on Bureau of Labor Statistics Information, provided by the United States Office of Vocational and Adult Education. To be completed by nominator and submitted with Nominator Form, Student Form and Essay, Letters of Recommendation, and photos postmarked on or before **May 1, 2011**. Must be typed (computer or typewriter). Applications/Guidelines.

(Attention Nominators! The judges look carefully at what you write in the nomination form. Your comments are an important factor in determining which students are chosen as winners.)

Answer in the following questions on a separate sheet of paper.

1. Elaborate on the student's specific skills: level of technical skill competency, ability to enter workforce, academic success. Describe how the nominee goes **above and beyond** the normal criteria.
2. Describe how this student has overcome the challenges (academic and/or personal) of being a nontraditional student.
3. Describe how this student is outstanding and why you selected this student as your nominee.
4. Add any other information that you feel will help the judges evaluate this candidate's application, including reasons not mentioned above, that qualify the candidate to be worthy of this award.

Part 2: Photos

Photos must be included for the nomination packet to be complete. Please include one head shot and a minimum of three action shots (the student working in his/her program; for example, a welder welding, brick mason laying brick, nurse caring for a patient, etc.). Remember, the best action shots are the ones that appear spontaneous with the subject seemingly unaware that his/her photo is being taken. The student should be recognizable in the picture, and safety requirements should be met. You must submit high quality digital photos. If more than four photos are submitted, CTE will select the best four.

Digital Photos: save in a JPEG format. Select 300 dots per inch (dpi), super-high quality (SHQ), or the highest quality available on your digital camera before taking the photos. Please do NOT change from the original size when saving as a JPEG.) Send your photo as an e-mail attachment or copy to a disk or CD and send it in the packet. ***In addition, print out all digital photos and attach them to the nominator packet.***

Part 3: Student Form

To be completed by student and submitted with Nominator Form and Questions, Essay, Letter of Recommendation, and photos postmarked on or before May 1, 2011. Must be typed (computer or typewriter).

Instructions

1. Write your essay, Part C, p.11.
2. Attach two letters of recommendation from someone other than your nominator (could be written by your Instructor, Director, Counselor, and Principal). Letters should address your strengths and technical skills, and support your nomination.

2. What are your career plans? How will your current CTE program assist you in reaching your career objective?
3. Describe any obstacles you have overcome as you pursued your interest in training for a nontraditional career.
4. What advice do you have for other students considering nontraditional programs?
5. Please provide the judges with information about your extra-curricular or outside activities.

Only include responsibilities you have had during the last two-three years. The following is a list of types of information that you may want to include:

- * Current awards or achievements (list years)
- * Family responsibilities (while enrolled)
- * Recent school or community involvement
- * Participation in program-related student organizations
