

PUBLIC NOTICE

Plus Mark, Inc. has applied to the Tennessee Air Pollution Control Division (TAPCD) for a [significant modification to their major source operating permit](#) subject to the provisions of paragraph 1200-3-9-.02(11) of the Tennessee Air Pollution Control Regulations (also frequently referred to as Title V regulations). A major source (Title V) operating permit is required by both the Federal Clean Air Act and the Tennessee Air Pollution Control Regulations.

EPA has agreed to treat this draft Part 70 permit as a proposed Part 70 permit and to perform its 45-day review provided by the law concurrently with the public notice period. If any substantive comments are received, EPA's 45-day review period will cease to be performed concurrently with the public notice period. EPA's 45-day review period will start once the public notice period has been completed and EPA receives notification from the Tennessee Air Pollution Control Division that comments have been received and resolved. Whether EPA's 45-day review period is performed concurrently with the public comment period or after the public comment period has ended, the deadline for citizen's petitions to the EPA Administrator will be determined as if EPA's 45-day review period is performed after the public comment period has ended (i.e., sequentially).

The applicant is **Plus Mark, Inc.** with a site address of Highway 11 E By-pass, Afton, TN 37616. They seek to obtain a significant modification to the major source (Title V) operating permit for their Giftwrap Printing and Converting Operation. The requested modification is to replace one 21.5 Million Btu/hr Natural Gas Fired Boiler with a new 16.34 Million Btu/hr Natural Gas Fired Boiler (Federal NSPS). However, it should be noted that this facility has a current major source operating permit.

A final determination will be made after weighing all relevant comments.
