

PUBLIC NOTICE

Vacumet Corporation, Metallized Paper Division has applied to the Tennessee Air Pollution Control Division (TAPCD) for [renewal of a major source operating permit](#) subject to the provisions of paragraph 1200-3-9-.02(11) of the Tennessee Air Pollution Control Regulations (also frequently referred to as Title V regulations). A major source (Title V) operating permit is required by both the Federal Clean Air Act and the Tennessee Air Pollution Control Regulations.

**The applicant is Vacumet Corporation, Metallized Paper Division with a site address of 5705 Commerce Boulevard, Morristown, TN. They seek to obtain renewal of a major source operating permit for their manufacturing of coated metallized paper and film. However, it should be noted that this facility has a current major source operating permit.**
