



LOBBYIST REGISTRATION

INSTRUCTIONS: This form must be completed and filed by every person qualifying as a lobbyist under the Lobbyist Registration and Disclosure Act (Tennessee Code Annotated §3-6-101, et seq.) within five (5) days after beginning lobbying activities for each employer. A check or money order in the amount of one hundred dollars (\$100), made payable to the Registry of Election Finance, must accompany your **first** registration form for the year. No fee is required for any registration filed for the same year after your first registration. Registration forms should be filed with the Registry of Election Finance, 404 James Robertson Parkway, Suite 1614, Nashville, TN 37243-1360 (615-741-7959). Please type or print all information in ink. Please notify the Registry of any change in address. **NOTICE:** Registered lobbyists, except volunteer lobbyists, are subject to a \$400 annual occupational privilege tax to be paid to the Tennessee Department of Revenue on June 1 of each year that the lobbyist is registered.
