## **INTRODUCTION**

Record Group 129, Legislative Log Sheets, covers the period 1987-1993. During this time period, the record groups has been considered "open ended," with additional log sheets being added to the microfilm. With the addition of the log sheets from 1993, this record group is now closed. Beginning January 1, 1994, all log sheets are entered on computer and are available in electronic format.

## **SCOPE AND CONTENT NOTE**

Record Group 129, Legislative Log Sheets, covers the period 1987-1993. The group consists of log sheets created by members of the Legislative Recording Staff of the Tennessee State Library and Archives. The log sheets are in reference to audio tapes of the Tennessee General Assembly.

Between the years of 1987 and 1989, all handwritten log sheet originals are included on the film. For the period January 1, 1990, through March 31, 1991, all log sheets were entered on the computer and are stored on diskette. From the period April 1, 1991 through 1992, most log sheets were entered on computer and are stored in diskette, with the remainder being left in handwritten form. These handwritten log sheets are being filmed to create a permanent record of the information. In 1993, the recording program was in the midst of changing software packages, so some log sheets were generated in the old format while others were generated in the new. Also, some log sheets had to be handwritten due to scheduling conflicts making a laptop computer unavailable to staff. The log sheets that were generated on the old software as well as the handwritten ones are also being filmed to create a permanent record. Beginning January 1, 1994, all log sheets have been entered on computer and are available in electronic format.
