SCOPE AND CONTENT NOTE

Record Group 198, Department of Health and Environment, Division of Information Resources, 1985-1987, consists of the annual reports from hospitals, nursing homes and related health care facilities in Tennessee. These reports are numerically statewide according to the Regional Service Areas. Within the service areas, facility reports are arranged by county and then alphabetically within that county.

These reports are required by the Department of Health and Environment to be submitted annually from every health care facility in operation in the State of Tennessee. These reports identify the health facility, whether private, governmental or church sponsored. The reports contain such information as the accreditation status, state approval status, services available to patients and current patient population. Also included in these reports are detailed financial statements of the operation and capital assets of the facility submitting the report.
