

# TENNESSEE ALCOHOLIC BEVERAGE COMMISSION MINUTES THURSDAY, JANUARY 31, 2019 10:00 a.m.

Pursuant to T.C.A. §8-44-108, meetings may be conducted permitting participation of electronic or other means of communication.

The meeting was held on January 31, 2019 in Nashville, Tennessee. Chairman Skiles and Commissioner Roberts were present at the meeting and Commissioner Jones participated in the meeting via electronic communication. The following staff members were present: Keith Hollingshead-Cook, CLEO Tubbs, Joshua Stepp, Christopher Dowell, and Nichelle Dorroh.

At the beginning of the meeting Commission Counsel Keith Hollingshead-Cook commented on the additional formalities for this meeting and Commissioner Jones identified a Michelle Goebel as present in the location from which he was participating. Additionally, Mr. Hollingshead-Cook confirmed for the record that all Commissioners received the same materials to be discussed, and Mr. Hollingshead-Cook noted that the votes for the meeting must be roll call votes.
