After Stepp presented the staff's concerns, Mr. Ibrahim, via Microsoft Teams, explained why the application should not be denied. After continuing to go on, Director Thomas chimed in and said the applicant had no financial viability and proceeded to summarize the request and recommend denial of the application. Commissioner Hamilton moved denial and the motion was seconded. The motion passed with three ayes.
