

**TENNESSEE ALCOHOLIC BEVERAGE COMMISSION

The June 2023 meeting was held on June 29, 2023 at 1:00 p.m. in Nashville, TN. Chairwoman Roberts, Commissioner Tomita and Commissioner Hamilton were present in the meeting room.
