

**Declaration of a Statewide Opioid Settlement Agreement Release and
Release of Claims Regarding Opioids Pursuant to Tenn. Code Ann. § 20-13-203**

WHEREAS, the General Assembly has found, as stated in Tenn. Code Ann. § 20-13-201, that a statewide coordinated resolution of state and local claims against entities involved in activities related to the manufacture, marketing, distribution, dispensing, or sale of opioids, or related activities, is critical to resolving current litigation and other claims regarding the opioid crisis and maximizing the financial commitment of those entities; and

WHEREAS, the State of Tennessee and a vast majority of other states and territories have entered into settlement agreements with Allergan Finance, LLC, CVS Health Corporation, Teva Pharmaceutical Industries Ltd., Walgreen Co., and Walmart, Inc. and their affiliates, subsidiaries and related entities; and


WHEREAS, more than 145 Tennessee local governments have joined these settlement agreements, including all ninety-five counties and all cities eligible to receive direct payments from these settlements; and

WHEREAS, the release of pending and future claims of governmental entities against these companies will maximize and protect the payments to be made to the State and its local governments pursuant to the settlement agreements; and

WHEREAS, pursuant to Tenn. Code Ann. § 20-13-203, upon written approval of the Governor and Comptroller of the Treasury, the Attorney General and Reporter has the authority to release any pending or future claim of governmental entities against Allergan Finance, LLC, CVS Health Corporation, Teva Pharmaceutical Industries Ltd., Walgreen Co., and Walmart, Inc. and affiliates, subsidiaries, and other entities related to these companies that are released in the Allergan Finance, LLC, CVS Health Corporation, Teva Pharmaceutical Industries Ltd., Walgreen Co., and Walmart, Inc. settlement agreements for activities related to the manufacture, marketing,


distribution, dispensing, or sale of opioids, or related activities, if the Attorney General deems the release necessary to the interest of the State in the resolution of the opioid crisis; therefore,


