SUBJECT: School Year 2019-20 Safe Schools Report

The Schools Against Violence in Education (SAVE) Act of 2007 provides that the commissioner of education annually report to the governor and General Assembly concerning "the prevalence of violent and disruptive incidents in the public schools, and the effectiveness of school programs undertaken to reduce violence and assure the safety and security of students and school personnel."

The attached report provides a summary of serious incidents occurring within Tennessee schools during the 2019-20 school year, as well as an overview of efforts currently undertaken to ensure the safety of students and staff.

Executive Summary

This report serves to meet the statutory requirement for the commissioner of education to report annually to the Governor and the Tennessee General Assembly the status of school safety measures and data on incidents in schools (T.C.A § 49-6-810, 49-6-4301, 49-6-4302). This report highlights the expectations, program implementation, and statistics related to school safety, specifically to identify "the prevalence of violent and disruptive incidents in the public schools, and the effectiveness of school programs undertaken to reduce violence and assure the safety and security of students and school personnel." The 2019-20 school year proved to be one of unprecedented challenges and a time in which the term "safety" assumed a new and expanded meaning.

As the COVID-19 emergency unfolded across Tennessee communities, the value of a community-focused, multi-hazard approach to school safety planning became apparent. By taking advantage of practices, agreements and relationships already in place, many schools and districts were able to continue providing critical nutrition and student supports when traditional school operations were suspended on Friday, March 20th. Buses not being used to transport students were instead used to deliver meals and instructional materials. School resource officers were able to assist with food service security and/or conduct welfare checks. SAVE Act Coordinators worked with district leadership in writing pandemic procedures based on CDC and state health guidance. In countless ways across the state, communities came together to ensure students were safe and supported.

These practices and partnerships have continued and been strengthened throughout the 2020-21 school year. The department's partnership with the Tennessee Emergency Management Agency (TEMA) has been instrumental in providing personal protective equipment (PPE) and critical cleaning and disinfecting supplies for free to Tennessee's public and private schools. Support from the Tennessee Department of Health has enabled school leaders to have direct access to the information and support needed to make difficult decisions regarding school operations. Perhaps most importantly, these partnerships are mirrored locally with county emergency management agencies and health departments to foster communication and collaboration at the local level.

While the pandemic has created unique obstacles this year, important school safety functions have continued. This includes the disbursement of annual Safe Schools funding, training of school safety personnel, and increasing the presence of school resource officers in Tennessee schools.

Emergency Preparedness

Emergency Operation Planning

The SAVE Act, passed in 2007, established specific and consistent requirements for districts related to providing a safe school environment, including the formation of district and school safety teams and requirements for the development of comprehensive safety plans. These plans, referred to as emergency operation plans (EOPs), outline how schools prepare for, respond to, and recover from emergencies. A well-developed and well-documented EOP ensures that plans and procedures are comprehensive and are communicated to everyone with a potential role during emergency situations.

It is important to note here the difference between a district and a school EOP. District EOPs set the stage for school-level EOPs by providing standards and, where appropriate, uniform response protocols. District EOPs also ensure that adequate and appropriate planning occurs with the broader school community and that district-level resources will be directed to support schools when needed. School-level EOPs provide the individually tailored planning, support and direction needed to address the unique needs of each school.

District and school EOPs are reviewed by an interdepartmental team on a <u>five-year cycle</u> that coincides with their county emergency management planning cycle. Each school district due for review has their district plan and 20% of their school plans reviewed during the cycle. The team is comprised of representatives of the Tennessee departments of Education, Health, Commerce and Insurance, Safety and Homeland Security and the Tennessee Emergency Management Agency. EOP reviews are conducted using an evaluation rubric that is aligned with EOP requirements identified in T.C.A § 49-6-805.

During the 2019-20 school year, 30 district EOPs were reviewed with the following findings:

Table 1: Districts Meeting EOP Requirements

During the 2019-20 school year, 90 school EOPs were reviewed with the following findings:

After reviews are conducted, the Office of School Safety provides technical assistance to districts to address any requirements that were not met, supporting districts in corrective actions to ensure strong plans are in place.

Conducting Emergency Drills

Training on school safety principles provide school personnel techniques for identifying strategies to prevent or mitigate threats and hazards, respond to emergencies and to ultimately recover from a crisis. Students are trained on emergency procedures, and emergency drills provide an opportunity to identify gaps in the training. The current drill requirements for schools are outlined in the table below:

Table 3: Emergency Drills

In addition to reviewing EOPs on a five-year cycle, 2018-19 school year drill logs were also reviewed. All drill logs from each school on the 5-year cycle are reviewed. Although the current school year was disrupted by the pandemic, schools were able to conduct many of the required drills prior to closing. 477 drill logs were reviewed during the most recent review cycle indicating the following:

Due to the unique circumstances of the 2019-20 school year, the department released guidance documents and toolkits to support districts as they closed and reopened school sites. Information on these resources, including for Safety and Operations that addressed drill requirements, may be found on the department's website here.

School Resource Officers

The 111th General Assembly amended T.C.A § 49-6-809 to prioritize the placement of school resource officers (SROs) in Tennessee schools. For FY20, the Tennessee General Assembly appropriated an additional \$20 million in one-time Safe Schools funding to support the placement of SROs in schools across the state that did not have a full-time officer in place during the previous school year.

During the 2019-20 school year, the department awarded \$7,466,700 for 57 districts to place 213 new, full-time SROs. The districts awarded funding during the 2019-20 school year were allowed to apply for a second year of funds. Fifty-one districts reapplied and were awarded

\$6,811,378 to support 195 school resource officers during the 2020-21 school year. Six districts did not reapply as their partner law enforcement agency was unable to recruit or place an officer within the current pandemic environment.

The department will continue to work closely with the Tennessee Department of Safety and Homeland Security to identify strategies to increase SRO placement with grant funds. Information about SRO Grant funding can be found in Appendix II.

The table below reflects a three-year trend in the number of SROs placed in schools.

School Safety Grant Programs

The department currently administers two grant programs to support school safety—the Safe Schools Grant and the SRO Grant.

Grant Program Overviews Safe Schools (Recurring)

- **Purpose:** Districts are required to use the results of a school security assessment developed by the Tennessee Department of Safety and Homeland Security as a needs analysis to drive the use of grant funds. Alignment with identified needs is validated during the grant approval process. Information about district level funding, including how these funds are being utilized can be found in <u>Appendix I</u>.
- **Awards:** Grants are awarded to all districts in proportion to their relative share of the BEP formula. Districts are required to provide a 25% local match that is adjusted for fiscal capacity.
- Appropriations:
 - o FY 18: \$4.8M in recurring funding
 - o FY 19: \$10M in recurring funding
 - FY 20: \$20M in recurring funding
 - o FY 21: \$20M in recurring funding (continuation)

SRO Grant-Non (Recurring)

• **Purpose**: Grant funds are limited to supporting the placement, training or equipment for full-time SROs in schools that did not have a full-time SRO in the prior year. Information about district level funding can be found in <u>Appendix II</u>.

• **Awards:** Any Tennessee school district may apply. Grants are in the amount of \$35,000 per SRO and require a 25% local match that is adjusted for fiscal capacity.

Appropriation: The grant program was set up for two years with the non-recurring FY 20 appropriation of \$20M in Safe Schools funding. Both of the grant program years are supported with this one-time appropriation.

Grants to States for Emergency Management

In October 2018, the department was awarded a five-year US Department of Education grant for the purpose of expanding the state's capacity to assist schools in the development and implementation of high-quality EOPs. During the 2019-20 school year, the following objectives were addressed:

Objective A: Expand training and support to districts with an additional staff position within the department, as well as contractual support, to enable the Tennessee School Safety Center to transition to a force multiplier model vial the use of training of trainers and technology to reach a larger and more diverse population.

- Hired a full-time School Safety Planning Coordinator.
- Established a cadre of School Safety Mentors, comprised of 12 school safety, law enforcement, and emergency management professionals. These mentors conducted 89 trainings in addition to providing technical assistance and developing resources. They were trained to deliver *Developing High-Quality EOPs, Reunification, Psychological and Emotional Recovery, PREPARE Postvention, Active Shooter training and Threat Assessment* training this year.

Objective B: Create training, curriculum and technology supports that enabled LEAs to more effectively monitor and support the development of building-level EOPs.

- The <u>District Level Emergency Operation Template</u> and <u>School Level Operation</u>
 <u>Templates</u> were revised to include a physical security section, a quick reference guide, a planning guide for students and staff with special needs and a pandemic annex.
- Members of the State Safety Team reviewed 30 district level EOPs and 90 school level EOPs.
- A <u>template for districts to track their emergency drills</u> was created. In addition, a drill log review process was implemented, as reported on page 9, in which drill logs were reviewed for 477 schools.

Objective C: Define the role of school resource officers and the first responder community in assisting schools in the development of building level EOPs and develop training and other resources to support that role.

- The State Safety Team met on a quarterly basis and formed 3 subcommittees:
 - Emergency Planning Committee: This committee has worked to build a new EOP review tool.

- Policy Committee: This committee has looked at current school safety policies to see if there were opportunities to streamline policies and to identify areas that need more guidance.
- Security Committee: This committee worked on the development of new SRO trainings, Memorandum of Understandings and the Security Assessment tool.

Objective D: Utilize research and best practices to develop a framework or template for ensuring relevant student transportation operations are integrated into district and school-level EOP processes and create training resources for transportation supervisors and drivers.

• Work will begin in 2021, which is year 3 of the grant.

Objective E: Maintain a partnership infrastructure that will facilitate collaboration and ensure sustainability beyond the grant period.

- Develop a formal relationship with Commerce and Insurance to ensure accountability of emergency drills
- Develop informal relationships with Tennessee Department of Safety and Homeland Security for monitoring of school security assessments
- Develop informal relationships with the Tennessee departments of Health and Mental Health for the development of resources and information

Transportation

Since the implementation of T.C.A. § 49-6-2116, the department has hired a director and a consultant to oversee training and monitoring associated with the new district transportation requirements. The team is responsible for overseeing supports in training and compliance as well as recommending school bus specifications. Significant accomplishments in these areas include:

- Training: Transportation supervisor training guidance has been developed and shared
 with districts to clarify the training process and supervisor obligations. Student
 Transportation Management Training has been developed and is currently being
 offered as an on-demand online course for initial supervisors. The department has also
 developed and conducted annual ongoing training for existing supervisors. One
 hundred-sixteen (116) existing supervisors completed annual ongoing training through
 the department's online training course in 2020. All supervisor training is being tracked
 and certified.
- Compliance: A monitoring system is in place to ensure compliance with state and federal pupil transportation requirements. To date, 92 compliance visits have been completed.
- Specifications- The Tennessee State Board of Education approved updated school bus specifications based on the department's recommendations on September 18, 2019.

In addition, the department is currently administering a \$3 million appropriation to establish a school bus seat restraint grant program. The program reimburses districts for the additional cost associated with adding seat restraints when purchasing new buses or retrofitting

qualifying buses already in operation. Twelve districts have been awarded grant funding to place 55 buses in service that are equipped with seat restraints.

Additional information regarding Tennessee's student transportation system and the seat restraint grant can be found in <u>Appendix III</u>.

Serious Incidents in Schools: School Safety Index

Serious incidents related to student behavior in Tennessee schools are tracked via the department's student management information system. For the purposes of this report, the department has developed a measure entitled the School Safety Index which includes those serious incidents deemed to be most directly related to the safety and welfare of students, including the following:

- Possession of a handgun
- Possession of a rifle or shotgun
- Possession of an explosive or incendiary device
- Possession of a weapon other than a firearm
- Assault of a teacher or staff member
- Assault of a student
- Sexual assault
- Aggravated assault of a teacher or staff member
- Aggravated assault of a student
- Attempted homicide

The table below indicates serious incident totals for school years 2015-16 through 2019-20. Due to the significant reduction in the number of days in which students were on campus as a result of COVID-19 school closures, 2019-20 data is not comparable.

In order to arrive at a school-level measure, the total number of the above incidents that have been reported for the school year via the student management information system are divided by a school's average daily membership (ADM) to arrive at a school safety index score. Scores for any schools reporting one or more serious incidents during the 2019-20 school year, aggregated by school district, are included in <u>Appendix IV</u>.

Using the same formula (i.e., serious incidents/ADM) to review Tennessee as a whole, the aggregate school safety index for Tennessee is presented below. Again, due to the significant reduction in the number of days in which students were on campus as a result of COVID-19 school closures, 2019-20 data is not comparable.

Road Ahead

While uncertainties remain as to when the current COVID-19 emergency will end, planning for recovery is important. Assuming schools are able to return to a more traditional operational format with the beginning of the 2021-22 school year, the department is developing plans now to ensure schools are prepared for a safe start. Specific steps currently being taken include:

- Implementation of an updated school security assessment process in cooperation with the Department of Safety and Homeland Security, including use of these assessments to guide local decisions regarding the use of Safe Schools funding
- Establishing strong district and school-level leadership via a renewed focus on fundamental school safety and preparedness practices as operationalized through an updated Tennessee School Safety Specialist Program (TSSSP)
- Support of the Tennessee General Assembly's commitment to placing an SRO in every Tennessee school by continuing the grant program begun in FY 20 while expanding the availability of high-quality training for all SROs

Appendix III: Tennessee Student Transportation Summary

The Danger Zone Statistics

As cars on the road and distracted driving have both continued to increase, so too has the prevalence of danger zones around school buses. The number of cars on streets grew by 27.4 million between 2012 and 2018. Distracted driving claimed 3,450 lives and injured 391,000 people in 2016. Sixty-five percent of illegal passing of school buses occur due to distracted drivers, while 35 percent occur because the driver did not know they had to stop. Tennessee bus drivers participate in an annual survey of illegal passing entitled *The Danger Zone*. Below are results for the 2018 and 2019 survey.

Appendix IV: School Safety Index

Description: T.C.A. § 49-6-4301 states that "the commissioner shall report to the governor and the General Assembly concerning the prevalence of violent and disruptive incidents in public schools." To fulfill this legislative mandate, the department has developed the School Safety Index. For each school, the reported sum of serious school safety incidents is divided by the school's average daily membership (ADM) to arrive at a percentage of enrollment or School Safety Index score. A higher index score indicates a relatively higher level of reported incidents. Schools that did not report any of the serious incidents identified below will not appear in the index:

- Possession of a handgun
- Possession of a rifle or shotgun
- Possession of an explosive or incendiary device
- Possession of a weapon other than a firearm
- Assault of a teacher or staff member
- Assault of a student
- Sexual assault
- Aggravated assault of a teacher or staff member
- Aggravated assault of a student
- Attempted homicide
