<p><b>What is the overall <a href="#">deductible</a>?</b></p>	<p><u>In-network/Out-of-network</u>:  <b>\$1,800/\$3,600</b> employee only;  <b>\$2,500/\$4,800</b> employee + child(ren);  <b>\$2,800/\$5,550</b> employee + spouse;  <b>\$3,600/\$7,200</b> employee + spouse + child(ren)</p>	<p>Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u>, each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u>.</p>
<p><b>Are there services covered before you meet your <a href="#">deductible</a>?</b></p>	<p><b>Yes.</b> <u>In-network preventive care screenings</u> at outpatient facilities; <u>In-network</u> outpatient occupational, physical, speech and applied behavior analysis therapies; other <u>in-network preventive care</u>; other outpatient services, including <u>primary</u> and <u>specialist</u> office visits, behavioral health and substance use, routine x-rays, labs, and diagnostics, reading, interpretation and results, telehealth, chiropractic and acupuncture, convenience clinics, <u>urgent care</u>, and pharmacy.</p>	<p>This <u>plan</u> covers some items and services even if you haven't met the <u>deductible</u> amount.
