Regarding the contract requirement to provide SUPPLEMENTAL FOOD ITEMS the RFP identifies many different Types of items such as QUEST Protein Granola Bar (Gluten Free)12/2.12 oz on the high-cost end and Low-fat 1% half pint of Milk on the low-cost end. We estimate that we will have to stock over 20 different items to meet this new requirement Please clarify how many different menu items we will be required to have available every evening and the specific total number we will have to provide per Cadet class size. As an Example, 75 Cadets will require 4 different items be provided and using a formula of 2 units per	See Pro Forma Contract Sections A.5.d.(4) and A.6. The State understands that there is a price-point difference in the items listed for Supplemental Food Items as a result of some of the items being a higher quality product that provides higher nutritional value aimed at generating increased performance gains and results. The State does not expect that each of the items be served at each setting but does expect enough of a sampling to provide a variety for individuals to choose from. The State offers an analogy of a salad bar – there may be 30 items on the salad bar, but some individuals may only select 3 while others may select 5 and if someone wants something that is not available, the person makes an alternate selection. Using the Respondent's numbers of 75, the State would not expect 75 Quest bars to be available
		Cadet, we will have to provide150 units in total. This clarification will be very helpful in calculating a proposal price.	expect 75 Quest bars to be available each time, but perhaps at least 10 and enough of the other items to allow individuals to choose from what remains

3. Delete Pro Forma section A.5.d.(4) in its entirety and insert the following in its place (any sentence or paragraph containing revised or new text is highlighted):

The Contractor shall provide and make available supplemental nutritional food items to Trooper cadets throughout the duration of the Cadet School. Supplemental nutritional food items shall not be used to replace any other meal period and are intended to provide for additional nourishment between the hours of dinner and breakfast. Supplemental nutritional food items shall be available between the hours of 6:00 pm CST and 9:00 pm CST unless the State agrees in writing for any changes to this schedule. The quantity and selection of supplemental nutritional food items to be provided each day throughout the Cadet School shall be determined similarly to how meal counts are determined as set forth in Section A.6. Supplemental nutritional food items must be those listed on Attachment J.
