- a) Education (general, appraisal, eminent domain).
- b) Real Estate appraisal qualification and experience with TDOT and other clients with emphasis on eminent domain valuation.
- c) Demonstrated ability to perform the work efficiently and meet schedules without compromising sound professional practices and compliance with TDOT's Guidelines for Appraisers, the Uniform Relocation Assistance and Real Properties Acquisition Policies Act, 42 U.S.C. § 4601, et seq., and USPAP (Uniform Standards of Professional Appraisal Practice).
- d) Evaluations on prior TDOT projects, if available.

The Department's Consultant Evaluation Committee (CEC) shall recommend the most qualified real estate appraisers to the Commissioner for selection and award of a contract.

Evaluation proceedings will be conducted within the established guidelines regarding equal employment opportunity and nondiscriminatory action based upon the grounds of race, color, religion, national origin, sex, creed, age and disability.
