Commissioner Kaegi was not present at the meeting. There was a quorum of two: Commissioner John A. Jones and Chairperson Mary McDaniel, and the meeting was conducted. Director Clayton V. Byrd, Staff Attorney Joshua Stepp, and CLEO Mark Hutchens were in attendance.

**Commissioner Jones motioned to approve the addendum to the agenda and Chairperson McDaniel seconded the motion; the motion was approved with three ayes.

As verified by TABC staff, Mr. Ryan is investing approximately \$100k into the business using personal funds, a line of credit, and operating funds obtained from CH Ryan, LLC.¹ The applicant will lease the premises from Retail Development Solutions, LLC at a monthly rental rate of approximately \$6,000; the lease terminates in 2022.² The TABC staff recommends conditional approval of this request, subject to receipt of the following items:

The retail store can sell alcoholic beverages that are manufactured within this state, are packaged in tamper-resistant sealed packages, and indicate on the packaging that the customer is prohibited from consuming the alcoholic beverage until the customer reaches the customer's final destination. In addition, the Executive Director of the Tennessee Alcoholic Beverage Commission shall also be given the authority to determine if cause exists to contest the issuance of the license to a store issued a letter of approval pursuant to T.C.A. § 57-3-803 and to take all necessary measures accordingly pursuant to law.

The Order of Delegation executed on April 26, 2016 remains in effect until July 1, 2016.
