As a result of an organizational examination conducted as of the 23<sup>th</sup> day of January, 2014, the examiner-in-charge filed with the Division, on the 7<sup>th</sup> April, 2014, a verified, written report on the organizational examination, and a copy of that report has been sent to the Company.
