**ORDER ADOPTING EXAMINATION REPORT WITH DIRECTIVES**

Pursuant to TENN. CODE ANN. §§ 56-22-101, *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance (“Division”) has examined certain affairs of Tennessee Valley Mutual Insurance Company (“Company”), a county mutual insurance company domiciled in the State of Tennessee. As a result of an examination conducted as of the 31st day of December, 2008, the examiner-in-charge filed with the Division, on the 25th day of May, 2010, a verified, written report on the examination, and a copy of that report has been sent to Tennessee Valley Mutual Insurance Company. (The Report on Examination of Tennessee Valley Mutual Insurance Company is attached as Exhibit A). The Division did not receive any written rebuttal to said examination report from the Company.

Pursuant to TENN. CODE ANN. § 56-1-411, the examination report regarding the affairs of Tennessee Valley Mutual Insurance Company filed with the Insurance Division of the State of Tennessee Department of Commerce and Insurance on the 25th day of May, 2010, is hereby **ADOPTED** as filed with the following **DIRECTIVES**:


1. The Company is **DIRECTED** to maintain certificates of deposit at book value.
2. The Company is **DIRECTED** to comply with TENN. CODE ANN. § 56-22-106(g) by using the words “county mutual insurance company” in their name or by displaying the words any time the company name is used. The company is further

directed that it shall not to use a name similar to any name already in use by any existing company organized and doing business in the United States, as to be confusing or misleading.


The adoption of this examination report shall not preclude the Department from imposing sanctions against Tennessee Valley Mutual Insurance Company for potential violations of the Tennessee Insurance Law which may be revealed in the examination report, it being the intent of this Order Adopting Examination Report With Directives merely to adopt the examination report filed by the examiner-in-charge.


