TennCare Medicaid EHR Provider Incentive Attestations for 2013 are due no later than 11:59 PM on **March 31, 2014**. These are attestations where you are answering the second part of Question 7 on the Provider Questions screen with "2013." Your patient encounter volume will come from calendar year 2012. Your meaningful use data will come from calendar year 2013. These are two totally different dates.

## 2014 Attestations

EPs may begin submitting 2014 attestations for meaningful use on April 1 (Question 7 = 2014). Your patient encounter volume will come from calendar year 2013. Due to a change made by CMS, ALL providers may use a 90-day period in 2014 for their meaningful use data, regardless of in what stage of the program they are.

**MEDICARE** payment reductions are scheduled to begin January 1, 2015. We highly encourage you to do your 2014 MU attestation as soon as possible so that we can report your status to CMS. Passing the MU attestation through TennCare Medicaid will help you avoid the Medicare payment reductions.
