### **Certification Requirements**

To be issued certification as a Hazardous Materials Decontamination, the candidate will:

#### Written Examination

- Perform to a minimum 70% competency on a 50-question examination for Hazardous Materials Decontamination.
  - Retest after 15 days and must be passed within one year of passing the practical.

### ☑ Practical Examination

- Successfully complete a skills evaluation, to a minimum of 70% competency and successful completion of all critical points.
  - Retest after 15 days
