## Director's Report

Randy Fox, Director of Firefighting Personnel Standards and Education gave a report on behalf of the Commission office.

- Website changes- we are looking at things we can add to website to make it more customer friendly.
  - We've added in-house practical booklets;
  - o Name change of Commission to reflect the actual name of the Commission;
  - In the future looking to add Fire Officer grading criteria and Safety Officer grading criteria so applicants know the standard they are being graded against
- Status of Administrative Assistant position Cheryl Deener has been hired effective September 3<sup>rd</sup> and that has been approved.
- Coordinator positions have been placed in the budget and approved to hire. Those positions should be posted on Sept. 4<sup>th</sup>. The posting will close on Sept. 18<sup>th</sup>.
- IFSAC Fall Board Meeting is Sept. 20-22. Awaiting approval for Randy to attend that meeting in Anchorage, Alaska.
- Pro Board:
  - We are working toward accreditation.
  - We will start the process in October.
  - We are working closely with Fred Piechota, Accreditation Manager, on this.
  - o It may be spring before we will be on board and have accreditation.
- Field Contracts:
  - Currently Terry Priest has been awareded Middle TN and has been approved. He also put in for East TN. We are awaiting approval on that.
  - Terri Whiteside put in For Middle and East TN as well. As of today, she has been approved for East TN. We are awaiting approval for Middle TN.
  - o Michael Gill is present today. He has applied for West TN and we are awaiting approval on that.

- Reciprocity: Greg Adams presented reciprocity applicants that are certified elsewhere and would like those certifications recognized in TN. (Spreadsheet handed out to Members)

  - Applications 26 28 the certification level was in question because HMA & HMO was combined
    in one application. Motion made, seconded and carried to provisionally approve all three
    applications once Commission office receives the correct paperwork that being separate
    application forms.

  - Application 40 Commission Member questioned why a problem. Greg explained the application was for Fire Officer 1, but what was submitted was for Fire Officer 3. Director Fox explained that the applicant did get obtain Fire Officer 2/3 or 3 in GA, but did not have the Fire Officer 1 prerequisite. He basically slipped through the cracks. Chairman Finucane asked for clarification

as to if he was reverting back to get Fire Officer 1 which he obtained via Pro Board in GA. Director Fox indicated that was correct. He is trying to get a lower certification when he already has a higher certification. A Commission Member asked for the rule regarding this to be read. After rule was read, Commission Member asked if seeking this reciprocity was in violation of that rule. Director Fox responded that it was and that the proposed rule changes would address this type of situation. Director also told the Commission that he has spoken with this applicant and made him aware that he would need to go back and get Fire Officer 1 and Fire Officer 2 in order to obtain Fire Officer 3 reciprocity as this is the correct procedure. **Motion made, seconded and carried to deny**.
