NOTICE: In accordance with T.C.A. § 68-115-208, every promotor must submit a preliminary report to the commission showing the number of tickets sold or issued for their professional contest, of which they shall pay a four percent (4%) gross receipt tax, or a flat \$500 fee, whichever amount is greater. Additionally, the promoter shall pay three percent (3%) of the first one million dollars (\$1,000,000), and one percent (1%) of the next two million dollars (\$2,000,000) of the total gross receipts from the sale, lease or other exploitation of broadcasting, television and motion picture rights for that contest, without any deductions for commissions fees, brokerage fees, distribution fees, advertising, combatants' purses or any other expenses or charges. This form, a copy of your gross receipt, and your corresponding payment must be submitted directly to the commission within ten (10) days of the event, otherwise penalty fees may be imposed. Submit your required materials to an onsite representative of the commission or mail them to *Tennessee Athletic Commission*, 500 James Robertson Parkway, Nashville, TN 37243.
