**Meeting Minutes for December 9, 2019  
Conference Room 1B  
Davy Crockett Tower**

The Tennessee Athletic Commission convened on December 9th, 2019, in the first floor conference room of the Davy Crockett Tower in Nashville, Tennessee. Glenn Kopchak called the meeting to order at 2:00 p.m. and the following business was transacted:

**BOARD MEMBERS PRESENT:** Patrick Wrenn (teleconference), Christy Halbert (teleconference), Dan McGrew (teleconference), and Steve Hannah (teleconference).

**ROLL CALL / NOTICE OF MEETING**

Director Kopchak called the meeting to order and took roll. Upon establishing quorum, he read the Notice of Meeting into the record.

**STATEMENT OF NECESSITY**

Mr. Hannah motioned to adopt the statement of necessity, which was seconded by Dr. Halbert. The motion passed unanimously by roll call vote.

**AGENDA**

Dr. Halbert motioned to adopt the agenda, which was seconded by Mr. Wrenn. The motion passed unanimously by roll call vote.

**MINUTES**

Mr. McGrew motioned to adopt the September minutes as written, which was seconded by Mr. Wrenn. The motion passed unanimously by roll call vote.

**DIRECTORS REPORT**

***Budget***

Director Kopchak reviewed the budget and provided a thorough analysis of the items that were of particular impact to the program this fiscal year, such as the reduction in licensing revenue for July and August and an increase in legal costs for July and September. The reallocation of event permits and refunds contributed to a decline in expected revenue for July and August. The Legal Division's participation in various legislative committee hearings and member briefs, which is required when new

rules are presented for review, resulted in an increase in legal costs to the program in July and September. As a result, the program is again running an overall deficit. As has been the case in the past, the program has depended on the revenues generated from a high grossing event to maintain program fiscal solvency for each 2-year sunset review cycle.

Complainant states that on a boxer application, the Respondent marked "No" for the following two questions: "Have you been convicted of a felony offense(s)?" and "Are there any criminal charges pending against you for felony or misdemeanor offenses at this time?" Complainant received a felony warrant from the State of Louisiana showing that the Respondent had a felony conviction of simple burglary on 10/11/2016 and was sentenced to five years of probation. The outstanding arrest warrant stated that the Respondent was charged with absconding/failure to appear on 07/31/2018.

**Recommendation: Authorize formal hearing. Authorize settlement with agreed suspension of license during time of probation. If no agreed suspension set for summary suspension.**

### **NEW BUSINESS**

Mr. McGrew inquired as to how the Commission could bring bigger events into Tennessee, especially boxing. Director Kopchak commended the Commission's continued efforts to bring its rules into line with industry standards as articulated by the Association of Boxing Commissions and Combative Sports (ABC) and its efforts to remove any other barriers to interstate commerce. Director Kopchak further iterated that the Commission may have another opportunity at the end of this fiscal year to introduce another rules package and formally adopt those remaining Unified Rules that have yet to be formally recognized in the Commission's rules.
