#### APPEAR BEFORE THE BOARD

Dennis Wallace – Hixson, TN – Present. Mr. Wallace is an owner of a barber shop that has pool tables. Mr. Wallace spoke with the board on the new rules concerning pool tables in the shops. Mr. Wallace stated his pool tables are ten (10) feet from the patrons. Mr. Wallace states that the tables are not in a separate room; that they are in an open area so that he can keep his eye on the whole area. Mr. Wallace asked the board if a revised rule could be added that grandfathers in shops that already have pool tables.

The board states that the new rule is not effect yet. The board stated that there is no grandfathering concerning pool tables. The board is concerned about the safety and health of having pool tables in a barber shop business.

MOTION was made by Mr. Cecil Groce and seconded by Mr. Vernon Winfrey to require a hard wall be installed around pool tables. Motion carried unanimously.

MOTION was made by Mr. Cecil Groce and seconded by Mr. Vernon Winfrey that once the rule of becomes effective that all barber shops will have to make the required changes. Motion carried unanimously.

Mr. Phillip Smith submitted an application for reciprocity from Missouri. Mr. Smith is licensed in Missouri with 1,000 hours in barbering.

MOTION was made by Ms. Cecil Groce and seconded by Mr. JaSanto Williams to request Mr. Phillip Smith obtain an additional 500 hours in barbering then take and pass the Master Barber examination to obtain a license in the State of Tennessee. Motion carried unanimously.
