

## MINUTES

The Tennessee State Board of Cosmetology held a meeting November 7, 2011 at 9:00 a.m. in Nashville, Tennessee.

The following Board Members were present: Linda Colley, Board Chairman, Nina Coppinger , Vice Chairman, June Huckleby, Muriel Smith, Pearl Walker and Diana Buchanan. Virgilene Lotze and Janet Wormsley were absent.

Others present: Beverly Waller Board Director, Terrance Bond Attorney for the Board and Hazel Buttrey Licensing Technician.

Meeting was called to order by Board Chairman Linda Colley.

Linda Colley, Board Chairman called for roll call.

Linda Colley, Board Chairman welcomed everyone to the board meeting and acknowledged the cosmetology schools in attendance.

Request for approval of the October 3, 2011 board minutes.

MOTION made by June Huckleby and seconded by Pearl Walker approval of the October 3, 2011 minutes. Motion carried unanimously.

### APPEAR BEFORE THE BOARD-

Ashley Kyler, Director of Education for Miller- Motte Technical College and Nicole Trotter Cosmetology Program Director for Miller-Motte Technical College are here today at the request of the Board concerning the approval of changes to the cosmetology clock hour programs which was presented to the Board at the October board meeting. From the information provided it appears additional hours were required in the cosmetology curriculum. Ms. Kyler and Ms. Trotter explained the proposal and stated they were aware that the wording of what was proposed was confusing.

MOTION made by June Huckleby and seconded by Nina Coppinger approval of Miller- Motte Technical Colleges changes to the clock hour cosmetology program. Motion carried unanimously.

Farnaz Esmaili is here today at the request of the Board after review of her application for reciprocity of cosmetology license from Iran. The Board had previously requested a breakdown of the 2700 hour curriculum she completed in Iran. She submitted the information to the board office which she advised was obtained by phone.

MOTION made by Nina Coppinger and seconded by Muriel Smith. Applicant will be required to take the cosmetology examination. Motion carried unanimously.

Akberet Asmelash Ghebremicael is here today at the request of the Board. The Board reviewed her application for reciprocity of license from Eritrea at the October board meeting and voted to request her appearance to get clarification as to what was covered in the six (6) months cosmetology training course.

MOTION made by Nina Coppinger and seconded by Muriel Smith to accept 720 hours of instruction completed in Eritrea and applicant will be required to complete an additional 780 hours of instruction and set for the State Board Cosmetology examination. Motion carried unanimously.

Kristin Lynn Cude requested to appear before the Board today concerning her application for reciprocity which was reviewed by the board at the October board meeting. Applicant hours of instruction in cosmetology were obtained thru apprenticeship in a salon. The Board voted to request she submit proof of a 5 year work history as a cosmetologist. Applicant explained to the Board she could only provide proof of a 3 year work history as a cosmetologist and also explain to the Board the apprenticeship program in the State of Missouri. She received instruction in the salon and she was taught from the Milday Cosmetology book.

MOTION made by Nina Coppinger and seconded by Diana Buchanan to approve Applicant to set for the cosmetology examination. Vote: 3 -YEAS / 2-NAYS

#### COSMETOLOGY SCHOOL APPLICATIONS-

We have received notification from Empire Beauty School that all repairs have been completed at the Brentwood location from the flood. All students and co-workers are back under one roof and life is back to normal at the school.

#### NO MOTION REQUIRED-

Application for change of location for Paul Mitchell the School Knoxville presented at the October board meeting. The change of location has taken place and inspection by the Board Member and Board

Inspector has been conducted. The school was found to be in compliance with all requirements and I'm requesting the Boards approval to issue school license.

MOTION made by June Huckey and seconded by Muriel Smith to issue school license. Motion carried unanimously.

Notification from Gene Wallace owners of International College of Arts and Beauty located in Chattanooga, Tennessee that the school has closed due to lack of enrollment.

#### NOT MOTION REQUIRED-

Submitted application, bond and floor plan for a new school of cosmetology to be located at Virginia College School of Business and Health (Knoxville). They are requesting approval of the application and they can begin advertising and recruiting students. As stated in the letter submitted they understand they must provide 20 student enrollment agreements to the Board and pass a final inspection of the school before beginning classes. They hope to provide the twenty (20) student enrollment agreements in early March and anticipated date for the first class is April 4, 2012.

MOTION made by June Hucceby and seconded by Muriel Smith approval of the applications submitted. Motion carried unanimously.

#### APPLICATIONS FOR EXAMINATION-

Applications for examinations that have felonies from Michelle Flemings, Channing Wright, Charlotte Bell and Meredith Brown. All the required information has been submitted, disclosure from the student and letter of examination recommendation from the school applicant attended.

MOTION made by Diana Buchanan and seconded by Muriel Smith approval of application for examination with signed consent orders. Motion carried unanimously.

#### APPLICATIONS FOR RECIPROCITY-RE-PRESENT

Application for reciprocity of aesthetician license from Virginia from Robin Ashley Almond. Certification from the Virginia State Board states applicant documenting training and experience acceptable to the Board were eligible to receive an aesthetician license by waiver of the examination. Applicant has submitted documents from American Spirit Institute School of Natural Aesthetics in Virginia stating she completed 600 hours of Professional Aesthetician Training and 600 hours Master Aesthetician Training. Also a break down of the curriculum is listed.

MOTION made by Nina Coppinger and seconded by Diana Buchanan to approve applicant to set for the aesthetician examination. Motion carried unanimously.

Leticia Pava and a gentleman who translated for her appeared before the Board at the October board meeting to discuss her application for reciprocity of cosmetology license at which time the Board requested she submit proof of a work history from Columbia where she obtained her training. She has submitted documentation from the Chamber of Commerce of Barranquilla which list her income in the profession from 2000 to 2010 for review by the Board.

MOTION made by Muriel Smith and seconded by Nina Coppinger to approve applicant to set for the cosmetology examination. Motion carried unanimously.

Application for reciprocity of cosmetology license from Christine Martin reviewed by the Board at the October board meeting. Hours of instruction verified by certification from New Jersey State Board of 1350. She is requesting the Board to review her work history for consideration for licensing.

MOTION made by Muriel Smith and seconded by Nina Coppinger to approve applicant to set for the cosmetology examination. Motion carried unanimously.

Application for reciprocity of cosmetology license from Genet Araya Meles. The Board had requested a break down of the curriculum she completed at Women's Beauty Club Hair Dressing Training program for 800 hours in Ethiopia. She has submitted the requested information for review.

MOTION made by Muriel Smith and seconded by Pearl Walker to request applicant to appear before the Board. Motion carried unanimously.

Application for reciprocity of cosmetology, aesthetician, instructor and manicurist license from Andrea Denise Mueller from Germany which was reviewed at the October board meeting. The Board requested additional information such as a break down of the subjects in the curriculums and hours of instructions completed in the curriculum in Germany.

MOTION made by Muriel Smith and seconded by June Huckeby to request applicant to appear before the Board. Motion carried unanimously.

## APPLICATIONS FOR RECIPROCITY-

Attorney Terrance Bond stated he has thoughts about the Boards approval process for reciprocity applications which he would like to share with Board Members. He advised he has had this discussion with Board Members before but it bears repeating. Mr. Bond stated Cosmetology Reciprocity Law states: The Board may grant a license to applicants who hold a valid license issued by another state or the District of Columbia and has substantially met the qualifications for licensing in Tennessee and he would like to underscore the word substantially not an exact match. Mr. Bond stated in the event an applicant has greater than 50% of hours in a curriculum he thinks the Board should look at that and not require applicant to return to school for additional hours but to test in Tennessee to determine how proficient they are in state law and the profession. This would make the process easier and the new administration is looking at quality of decisions to make sure they are made in view of the law without being unduly restrictive on individuals trying to enter the professions in Tennessee. He would like the Board Members to keep that in mind because he might make such recommendations on applications that will be reviewed. In the event the Board feels an applicant might not have met all qualifications the Board has the decision to require the applicant to take the state board examination. Mr. Bond stated after several questions from Board Members that if an applicant holds a valid license from another state does not have a five (5) year work history and has a shortage of hours in the curriculum required in Tennessee the Board should review the hours to determine if the percentage of hours would be substantial to meet license requirements in Tennessee. Mr. Bond states that reciprocity is a short cut to get license and he feels that is the reason the Legislature stated substantially in the wording for reciprocity requirements. Mr. Bond stated he would not be making any decision for change but it is his responsibility as legal counsel for the Board to bring this to the Board Members attention. Mr. Bond advised the process is being looked at by someone other than himself and it is his duty as legal counsel to make the Board aware. Mr. Bond stated this conversation is also a result of complaints from applicants that are required to return to school to complete additional hours in curriculums and in several circumstances the complaints have gone beyond the department. Mr. Bond stated it is his responsibility to make sure the Board's decision is tied directly to the law. Mr. Bond suggested that an applicant holding a valid license issued by another state board, no (5) five year work history and hours or short of what is required in the curriculum in Tennessee the board should consider 60% of hours as substantial. Mr. Bond stated he does not make the decisions for the Board and Board Members should do what the majority determines is best.

Board Member Nina Coppinger stated she was not comfortable with making changes to the reciprocity approval process at this time and she would like to make a motion on the current application for review requiring reciprocity applicant Lacy Kemp to complete one hundred (100) hours of instruction in the esthetics curriculum and pass the state board aesthetician examination. Motion carried unanimously.

Application for reciprocity of cosmetology license from Wisconsin for Kim Luu. Certification from the Wisconsin State Board states she received license in that state by endorsement from Vietnam 08/02/2011. Additional documentation from Madison Area/Technical College.

MOTION made Nina Coppinger and seconded by Muriel Smith to approve applicant to set for the cosmetology examination. Motion carried unanimously.

Application for reciprocity of aesthetician license from Kansas from Lacy Kemp. Certification from the Kansas State Board verifies she completed 650 hours of instruction in the curriculum and original date of licensing 09/09/10. No 5 year work history.

MOTION made by Nina Coppinger and seconded by Pearl Walker Applicant will be required to complete 100 hours of instruction in the esthetics curriculum and pass the state board aesthetician examination to qualify for license. Motion carried unanimously.

Application for reciprocity of cosmetology instructor license for Sammy Jones from Mississippi. Certification from the Mississippi State Board verifies 1500 hours of instruction in the cosmetology curriculum and states instructor hours received out of state. She stated she completed her instructor training in the State of Alabama. She was able to obtain a letter from the Alabama State Board stating records show she attended the Master's Institute in 1994 and obtained 750 hours. No instructor examination was indicated.

MOTION made by Muriel Smith and seconded by Diana Buchanan approval of the application for instructor license. Motion carried unanimously.

Application for reciprocity of cosmetology license for Stephanie Baumberger from Florida. Certification verifies 1200 hours in the curriculum and original date of licensing as 03/17/2008 therefore no 5 year work history.

MOTION made by Nina Coppinger and seconded by Muriel Smith Applicant will be required to complete 300 hours of instruction in the cosmetology curriculum and pass the state board examination to qualify for license. Motion carried unanimously.

Application for reciprocity of cosmetology license for Mallory Elizabeth Droke from Florida. Certification from the Florida State Board verifies 1200 hours in the curriculum and original date of licensing as 10/08/2007 therefore no 5 year work history.

MOTION made by Nina Coppinger and seconded by Pearl Walker applicant will be required to complete 300 hours of instruction in the cosmetology curriculum and pass the state board examination to qualify for license. Motion carried unanimously.

Application for reciprocity of cosmetology license from Rebekah Wolfe from Missouri. Certification verifies she completed 3000 hour apprentice hours in the curriculum and her original date of licensing as 03/06/2000. Motion carried unanimously.

MOTION made by Nina Coppinger and seconded by Diana Buchanan to approve applicant for the cosmetology examination. Motion carried unanimously.

Application for reciprocity of manicurist license for Nga Nguyen from Georgia. Certification verifies 525 hours completed in the curriculum and original date of licensing as 08/20/2007 therefore no 5 year work history.

MOTION made by Diana Buchanan and seconded by Nina Coppinger applicant will be required to complete 75 hours of instruction in the curriculum and pass the state board manicurist examination to qualify for license. Motion carried unanimously.

Application for reciprocity of manicurist license for David Bui from the State of Georgia. Certification verifies 525 hours in the curriculum and original date of licensing 12/04/2008.

MOTION made by Diana Buchanan and seconded by Nina Coppinger applicant will be required to complete 75 hours of instruction in the curriculum and pass the state board manicurist examination to qualify for license. Motion carried unanimously.

Application for reciprocity of cosmetology license for Julia Alligood from the State of Georgia. Certification verifies she completed 1325 hours in the curriculum and is licensed as a Hair Designer since 12/18/2009.

MOTION made by Diana Buchanan and seconded by Pearl Walker applicant will be required to complete 175 hours of instruction in the cosmetology curriculum and pass the cosmetology examination to qualify for license. Motion carried unanimously.

Application for reciprocity of cosmetology license for Lourdes Padilla from Wisconsin. Applicant obtained license in Wisconsin by endorsement from Mexico.

MOTION made by Nina Coppinger and seconded by Muriel Smith applicant will be required to take the state board cosmetology examination. Vote: Five (5) YEAS and One (1) NAYS.

Application for reciprocity of cosmetology license from Australia from Steven Handyside. Statement submitted: In Western Australia qualifications are only received after 48 months of on-the-job and off-the-job training are completed to hairdressing government standards. This equates to 1824 hours per year, which in 48 months equates to 7296 hours. Trade Certification for completion of apprenticeship for the trade of hairdressing submitted. Certificate from Taylor Weir School of Hairdressing submitted also.

MOTION made by Nina Coppinger and seconded by Peal Walker applicant is required to take the state board cosmetology examination. Motion carried unanimously.

Application for reciprocity of aesthetician license for Bronagh Paladino. Certifications submitted states applicant is licensed in New York by Equivalent Experience from Ireland. Applicant is licensed in North Carolina by reciprocity and applicant is licensed in Florida by endorsement. No information submitted for hours of instruction in Ireland.

MOTION made by Nina Coppinger and seconded by Muriel Smith applicant is required to take the state board cosmetology examination. Motion carried unanimously.

Application for reciprocity of cosmetology license from Magdalena Lopez-Valdez from Mexico. Certification submitted from the Georgia State Board verifies she obtained license in Georgia by reciprocity. She has submitted information as to her instruction in the curriculum and break down in the curriculum in the school she attended in Mexico.

MOTION made by Nina Coppinger and seconded by Diana Buchanan applicant is required to take the state board cosmetology examination. Motion carried unanimously.

#### EXTENSION REQUEST-

Request for extension from Audrey Garcia Lulow. The Board reviewed this extension request at the October meeting and declined the request. The initial physician statement stated she was under the physician care for arthritis for her knee and she was restricted from walking up and down stairs or sitting for prolonged periods of time. The physician statement submitted states due to her condition the pain and instability she is unable to drive.



MOTION made by Nina Coppinger and seconded by Muriel Smith to approve the request for extension. Motion carried unanimously.

MISCELLANEOUS-

Request from Ms. Perkins Continuing Education Coordinator for TSU to set date for the 2012 Instructor Seminar. Dates submitted: August 12-13, 2012 and August 5-6, 2012.

MOTION made by Muriel Smith and seconded by Nina Coppinger to approve dates of August 12-13 for the 2012 instructor seminar. MOTION carried unanimously.

Request from Leslie Renee Shumate approval to take the aesthetician practical examination without turning on the galvanic or high frequency machine due to pregnancy.

MOTION made by Muriel Smith and seconded by Nina Coppinger to approve the request. Motion carried unanimously.

Request from Erica Shotwell to retain hours she completed in the cosmetology curriculum in high school. She enrolled in the high school curriculum in 2001 and enrolled in the cosmetology curriculum at Paul Mitchell the School Memphis in 2009 to complete hours.

MOTION made by Muriel Smith and seconded by Pearl Walker to request Ms. Shotwell to appear before the Board and also to notify Paul Mitchell the School Memphis. Motion carried unanimously.

Field trip request from Image Maker Cosmetology School. The school would like for cosmetology and aesthetician students be permitted to do hair and makeup for Nossi's photography models. The studio is down the street from the school and has a styling area for hair and makeup. An instructor would take approximately 3-4 students each Tuesday afternoon for approximately 2 hours to the studio. The photography studio would also provide the students with photos of their work each week which would help the student build a styling portfolio. Each week would be a different theme. Nossi would email a picture of the models to be used each week in advance to allow students attending the photo shoot time to plan the style and makeup that would be appropriate for that shoot.

MOTION made by Nina Coppinger and seconded by Muriel Smith to decline the field trip request. Motion carried unanimously.

Request for a mobile pampering party business for girls ages 4-13. This individual is not licensed but has experience as a former Avon and Mary Kay Beauty consultant. Services would be performed in the home it would be mini-pedicures, mini-manicures and mini-facials.

MOTION made by Muriel Smith and seconded by Diana Buchanan to decline this request. Motion carried unanimously.

Follow-up response from Gene Wallace as to the discussion at the October meeting concerning natural hair stylist performing shampoo services in a salon on clients other than clients they are performing natural hair styling service for. The Board stated at the October meeting that natural hair stylist should only perform shampoo services for the clients they are to perform natural hair styling services on. Mr. Wallace states he agrees with Mr. Bond that this is a topic that should require further clarification regarding state rules, and he hope this will be a topic of consideration when the Board reviews the laws and rules for updating.

Notification from the University of Tennessee planning committee with dates for the first meeting for planning the 2012 instructor seminar. The meeting will be held December 12, 2011 at the University of Tennessee Conference Center in Knoxville. After discussion the decision was made that Nina Coppinger Diana Buchanan will attend this meeting.

The Board had received a request from Jean Glick concerning allowing her dog in her shop and she provided a medical document which states her dog is a therapy dog. Therapy dogs are considered service animals.

MOTION made by Nina Coppinger and seconded by Diana Buchanan approval of the request to permit therapy dog in the shop. Motion carried unanimously.

A Notice of Violation issued April 8, 2011 alleges that the new owner of a licensed cosmetology shop failed to obtain a new license to operate the shop within thirty (30) days of the ownership change. In addition, the Notice alleges that three (3) unlicensed individuals were observed practicing manicuring in the shop, a hot wax machine and waxing implements were found in the shop, two (2) dogs were found in the shop and drill bits which had previously been used were left in an unsanitary condition.

**Recommendation: Authorize formal hearing with authority to settle by Consent Order and payment of a \$2,000.00 civil penalty.**

**History: No prior complaints.**

March 24, 2010 Notice of Violation alleges that one (1) individual was practicing cosmetology in a licensed shop without her license displayed. The Notice also alleges that various tools and implements not in use were not stored as required.

**Recommendation: Close with a letter of warning.**

- 61. 201002465-1 (RE-PRESENT)**

**History: No prior history indicated**

June 22, 2010 Notice of Violation regarding a cosmetology school states none of the instructor's licenses are posted, and there was no instructor for natural hair courses. Students were eating in the classroom, were not wearing uniforms, some did not have kits and the shampoo area was unsanitary.

**Recommendation: Close with a letter of warning.**

- 62. 201001137-1 (RE-PRESENT)**

The Board previously authorized the issuance of CEASE and DESIST advisory notice upon review of allegations that an individual was allegedly performing cosmetology services for customers or other person in a bank. Counsel has diligently searched for, but been unable to locate, address or licensing information for the individual.

**Recommendation: Close and flag.**

- 63. 201003582-1**

A Notice received from the Texas Department of Licensing and Regulation ("Texas Department") states that the Respondent, who has applied to receive a Tennessee manicurist license by reciprocity from the state of Texas, fraudulently obtained hours of instruction and reported such hours to the Texas Department in order to obtain a license. The Respondent entered into an Agreed Order with the Texas revoking her license and agreeing to pay a \$2,500.00 civil penalty.

**Recommendation: Deny the license application.**

**64. 201101933-1**

A consumer complaint alleges that the consumer and her family contracted Norwegian scabies after receiving service from a licensed cosmetologist who knowingly gave service to the family while infected with the disease. The stylist did not file a response to the complaint; however, the owner of the shop indicates that the stylist only rented space from her, that she was not an employee of the shop, that the stylist failed to disclose her condition while she rented space in the shop and that the stylist no longer services clients in the shop.

**Recommendation: Request that the stylist submit to a medical examination and/or provide records pertinent to her health status during the time the consumer received service. If records/examination indicate that the stylist is currently contagious, enter a summary suspension Order. If records indicate that the stylist is not currently contagious or infected, but was during the time the consumer received service, Authorize formal hearing with authority to settle by Consent Order of License Revocation.**

**65. 200802661-1**

The above-referenced complaint does not allege a violation of the Cosmetology Act.

**Recommendation: Close with no action.**

**66. 201003470-1**

November 5, 2010 Notice of Violation alleges that a skin care shop was opened for business before received the required inspection. A license to operate the shop was issued less than thirty (30) days following the issuance of the Notice.

**Recommendation: Close with a letter of warning.**

**67. 201100780-1**

A consumer complaint alleges that the consumer was injured after a licensed cosmetologist applied hair dye to her eyelashes during an eyelash tinting procedure. The licensee denies using hair color on the consumer's eyes, stating that she used last tint on

the consumer's eyes and that the product might have oxidized prior to use, which required her to apply the product a second time to the consumer's eyes. In contrast to the licensee's statement, the receptionist for the shop made an entry on the consumer's account record the day the consumer received services indicating that the licensee did use hair dye on the consumer's eyes because she could not locate the last tint product.

**Recommendation: Authorize formal hearing against both the shop owner and the licensed cosmetologist, with authority to settle by Consent Order and payment of a \$1,000.00 civil penalty.**

**68. 201100859-1**

A consumer complaint alleges that the consumer's ten year-old daughter sustained chemical burns after her visit to a licensed cosmetology shop where the cosmetologist applied a chemical relaxer to her hair and then advised the child not to wash her hair for forty-eight (48) hours following the service due to the adverse reaction. The consumer states that she attempted to contact the cosmetologist on two (2) occasions to discuss her concerns regarding the service with the cosmetologist—the consumer alleges that the licensee never responded to her requests. A request for response to the consumer's complaint was mailed to the licensee—there is no record of a response in the Board office.

**Recommendation: Close with a strong letter of warning.**

**69. 201100845-1**

A complaint filed by the mother of a former student at a licensed cosmetology school alleges that the school failed to provide her and the student sufficient information concerning the student's outstanding fee balance after the student elected to withdraw from the school. According to the mother, this is due to a dispute between the student and an instructor at the school, who the mother alleges treated the student in a racially discriminatory fashion, including intentionally damaging the student's hair during a color demonstration after the student complained to school administrative personnel that she was not learning from the instructor. The school disputes the mother's allegations, stating that, according to its business records and its discussions with both students and instructors with knowledge of the situation, the student's concerns about the instructor's teaching methods were allayed quickly after the student complained and that the student appeared satisfied with her color service immediately after receiving it. According to the school, multiple members of the school's administrative staff spoke with the student and her parents concerning the withdrawal process and the student's outstanding balance—the school alleges that these conversations were often contentious and did not result in a mutually agreeable resolution. The school states that, in an effort to appease the mother and student, it has agreed to adjust the student's remaining balance to zero. The Board office has not received any additional information from the student or her mother concerning the dispute with the school.

**Recommendation: Close with no action.**

**70. 201101939-1**

A former student at a licensed cosmetology school alleges that she was wrongfully terminated from the school and that the school is stealing from the state of Tennessee and the federal government by refusing to issue her financial aid credits and continuing to charge her for supplies she never received. The school states that the student was terminated due to exceeding the number of permitted absences from school without first obtaining approval for a leave of absence. Further, the school states that the student was credited all monies which were due her pursuant to her contract with the school after proper procedure had been followed. The school provided extensive documentation supporting its determination to terminate the student for excessive absenteeism. In addition, the school provided a detailed accounting of all charges borne by the student for attendance, supplies, etc. and also provided acknowledgement sheets signed by the student showing which supplies which issued to the student and the total costs of such supplies.

**Recommendation: Close with no action.**

**71. 201002961-1**

The Board previously authorized a formal hearing with authority to settle by Consent Order and payment of a \$2,000.00 civil penalty on allegations that the owner of a licensed manicure shop failed to properly sanitize one (1) or more pedispa chairs in the shop and that dirty files and buffers were left at work stations in the shop. Counsel for the shop owner has indicated that the shop owner would like to settle the violation but requests a reduction in the civil penalty to \$750.00, which is commensurate with his ability to pay.

**Recommendation: Authorize formal hearing with authority to settle by Consent Order and payment of a \$750.00 civil penalty.**
