

## Minutes

The Tennessee State Board of Barber Examiners held a meeting June 20, 2011 9:00 a.m. Nashville, Tennessee.

The following members were present: J.B. Loring President, Joe Jones Vice President, Larry High, Donald Collins and Ralph Payne.

Others present: Beverly Waller, Executive Director, Terrance Bond, Staff Attorney and Hazel Buttrey, Licensing Technician.

J.B. Loring, President called the meeting to order.

J.B. Loring, President ask for roll call.

J.B. Loring, President asked all to join in prayer.

J.B. Loring, President called for "Pledge of Allegiance".

J.B. Loring, President called for change or approval of the May 16, 2011 board meeting minutes.

MOTION made by Ralph Payne and seconded by Joe Jones for approval of the May 16, 2011 board meeting minutes. Motion carried unanimously.

### APPEAR BEFORE THE BOARD-

Mr. Rick Bundy who submitted an application for a barber school to be located at Genesis Career College's Nashville location is here at the request of the board. Board Members reviewed the application for a new barber school at the May 16, 2011 meeting and voted to request Mr. Bundy to appear before the Board to discuss his application. Mr. Bundy stated the proposed barber school has 7 students enrolled. Genesis Career College's Lebanon, Tennessee campus currently has a barber program. Mr. Bundy stated the barber school is ready for inspection now.

MOTION made by Ralph Payne and seconded by Larry High for the Board Member and Board Inspector for the are to inspect the barber school for approval to open. Motion carried unanimously.

Mr. Michael Sales is here today at the request of the Board. The Board reviewed Mr. Sales application for reciprocity of master barber license from Alabama at the April board meeting. Mr. Sales apprenticed under a master barber for 2 years to qualify for master barber license in Alabama. Mr. Sales has submitted a letter from Johnsons Income Tax and Accounting Services which states he was a client from January 10, 1995 to December 31, 2007 as the sole proprietor of Mike & Bill's Barber Shop which is located in Huntsville, Alabama. Also we have another letter from a CPA firm which states Mr. Sales has been a client of the CPA firm since May 31<sup>st</sup> 2008 and the date of the letter is 06/09/11. We have a letter from the Madison County Commissioners stating he obtained license as a barber in 1995.

MOTION made by Larry High and seconded by Donald Collins to approved Mr. Sales application for reciprocity of master barber license in Tennessee. Motion carried unanimously.

Applications for master barber examination from Robert C. Mattison and Allen Conner who have felonies. All required information has been submitted the disclosure from the student and letter of examination recommendation from the barber school attended.

Ms. Stone is an employee of Ralph Payne at Queen City Barber College and Mr. Payne stated to the Board he was well aware of Ms. Stone illness. Ms. Stone recently attended the master barber instructor seminar held at the University of Memphis June 12<sup>th</sup>-13<sup>th</sup>.

#### OTHER BUSIENSS-

President J.B. Loring explained to the Barber Board Members there is a bill in Metro Council to allow barber and cosmetology shops to open in residential areas. This bill had previously been submitted to Metro Council but the bill now up for second reading has

been revised. This bill would allow several business including barber and cosmetology shops to open in residential areas and would prohibit any signs posted at shop locations in residential areas. The bill will come up for second reading this week.

Board Members discussed the issue of unlicensed activity in the field of barbering which is apparently becoming a major issue in the state. Individuals with no license are performing barbering services in homes and some unlicensed activity is occurring in shops. Suggestion was made that Barber Board Members should gather all license barbers in your area to discuss this issue and perhaps come up with ideas to attempt to resolve this matter.
