4) Cost of Hearing

<u>LEGAL REPORT:</u> <u>ADRIAN CHICK, ASSISTANT GENERAL COUNSEL</u>

1. Case No.: L09-FUN-RBS-2009021181

This complaint alleges the Respondent funeral establishment failed to pay for embalming services within a reasonable amount of time despite several notifications.

Response: Respondent states that the payment was overlooked initially but later paid.

Complaint History: Several related complaints.

Recommendation: Authorization for hearing.

A motion was made by Clark McKinney to accept Counsel's recommendation.

2. Case No.: L10-FUN-RBS-2010001471

This complaint alleges the Respondent paid for burial vaults on several occasions with checks that were not honored by the bank due to insufficient funds.

Response: Request for response was returned by the post office after three delivery attempts.

Complaint History: Several related complaints.

Recommendation: Authorization for hearing.

A motion was made by Clark McKinney to accept Counsel's recommendation.

3. Case No.: L10-FUN-RBS-2010006961

An inspection on February 3, 2010 revealed the following violations:

- TCA 62-5-313 A dressed and casketed body lacks a permanent identification device;
- Rule 0660-06-.02 Casket prices on Casket Price List do not match price range on General Price List;
- Rule 0660-06-.02 Outer burial container prices on Outer Burial Container
 Price List do not match range on general price list;
- Rule 0660-06-.02 Price ranges for Immediate Burial are not accurate;
 and
- Rule 0660-06-.02 Description of merchandise not provided where required on Statements of Funeral Goods and Services Selected.

Response: No response received.

Complaint History: Several open complaints.

Recommendation: Authorization for hearing.

A motion was made by Clark McKinney to accept Counsel's recommendation.

4. Case No.: L10-FUN-RBS-2010006971

An inspection on February 9, 2010 revealed the following violations:

 Rule 0660-06-.02 - Statement of Funeral Goods and Services Selected reflects charge of \$1,365 for basic services in addition to a charge of \$1,225 for direct cremation;

- Rule 0660-06-.02 Price charged for flower car exceeds the price of this item on the General Price List; and
- Rule 0660-06-.02 Prices for direct cremation on General Price List are incorrect with regard to the cost of the alternative container.

Response: The Respondent states that he has refunded \$65 for the flower car and \$165 for transfer of remains. The Respondent has no intention of refunding the \$1,365 and believes the charge is appropriate.

Complaint History: None.

Recommendation: This complaint was first presented at the April 13, 2010 board meeting at which time the board requested the case be sent to investigations. The investigation has been completed and Legal recommends a Consent Order assessing a civil penalty of \$2,500 and authorization for hearing.

A motion was made by Clark McKinney to accept Counsel's recommendation.

5. Case No.: L08-FUN-RBS-2008013461

This complaint alleges that the Respondent mishandled pre-need funds for the funeral of her husband. The decedent made changes to his arrangements five to six times over the course of several years and each upgrade was funded with an additional policy. The Complainant believes all funds received from the insurance policies were not credited to his funeral expenses.

Response: An investigation was conducted which included gathering of payment records from each of the insurance policies. All money is accounted for and part of the funds was used to fund a pre-need plan for the Complainant.

Complaint History: None related.

Recommendation: The funds appear to be accounted for. The pre-need policy purchased by the Complainant appears to bear her signature. Legal recommends closing the complaint.

A motion was made by Eugene Williams to accept Counsel's recommendation.

6. Case No.: L07-FUN-RBS-2007060631

An inspection on April 24, 2007 revealed the following violations:

- TCA 62-5-107 Copy of license and latest inspection report of crematory uses is not available for inspection;
- Rule 0660-4-.03 [Change of Ownership] A change of ownership occurred on January 1, 2007 but the Board has not been notified;
- FTC Rules Caskets in selection room do not agree with the Casket Price List:
- FTC Rules Range of casket prices on the General Price List does not agree with Casket Price List;
- FTC Rules General Price List does not contain price for receiving remains from another funeral home; and
- FTC Rules General Price List lacks two required disclosures (casket price range and outer burial container price range).

Response: No response was received.

Complaint History: 200504277 closed.

Recommendation: This complaint was presented to the board on October 9, 2007. Subsequent to that time the establishment has closed and Legal request closure of the complaint.

A motion was made by Tony Hysmith to accept Counsel's recommendation.

7. Case No.: L08-FUN-RBS-2008012291

This complaint alleges that the Respondent published an advertisement in several directories listing an establishment name that was not licensed by the Board as an establishment. The telephone number was forwarded to an establishment in Kentucky who would report that they could provide services in Tennessee.

Response: Respondent states that in anticipation of buying a former establishment in Tennessee, it had obtained an unlisted telephone number that was not to be published. Apparently the Yellow Book purchased this information

from the Real Yellow Pages, and then published it without his knowledge or authorization.

Complaint History: None

Recommendation: This complaint was first presented to the board on August 12, 2008. This establishment was never issued a license; and therefore, is not in operation. Legal recommends the complaint be closed.

of the current license and latest inspection report of the crematory that the funeral home uses were not available for inspection, the price range on the General Price List for cremations was not accurate and the reason for embalming was not listed where required on a Statement of Funeral

Goods and Services Selected
