1. Case No.: L14-FUN-RBS-2014006021

Complaint:

- Complainant made arrangements with Respondent establishment for her father a week before he passed away.
- Upon death, Respondent told complainant that they would not use the deceased's VA insurance. He told her that insurance takes anywhere from 6 to 8 months to pay and it will be on a card.
- Because Respondent would not take the VA insurance, she had to change the arrangements to a lower price. She also had to borrow money from relatives.
- After the burial, she started calling Respondent about when the death certificate would come in. Respondent told her that it would take three to six weeks.

- After that time period had passed and there was still no certificate, she called the County Health Department and the hospital, and they both told her there was no record.
- When she called the funeral home and told them this, they said that the director would call her back, but he never did.
- She called the County Health Department again, and they told her that they have called the funeral home three times asking for paperwork.

Response:

- Arrangements:
 - When complainant came in to select arrangements for her father, she chose a pricey package and told him that the VA would pay for it.
 - Respondent informed her that the VA would reimburse her through a card they will send to her, and it may take a while for her to receive the reimbursement.
 - Therefore, she chose a lower priced service.
- Death Certificate:
 - The death certificate was prepared and mailed the same week.
 - When Respondent called the hospital to check on the certificate, they realized that they had used the wrong address.
 - Because of the delay, they reached out to the Health Department so they would be aware of the situation.
 - Respondent states that they kept the complainant informed throughout this process.
 - o A member of the family came on April 1st to pick up the death certificate when it finally arrived at the funeral home.

Timeline:

- January 15th date of death
- March 27th date death certificate filed
- April 1st family received death certificate from the funeral home

Close with a Letter of Warning
