This is an anonymous complaint submitted against the Respondent alleging the Respondent is acting in the capacity of a Funeral Director and Embalmer despite the Respondent surrendering both their licenses.

The Respondent has not responded to the complaint. The two funeral homes associated with the Respondent did respond to the complaint and indicated that they are either not working with the Respondent or the Respondent is not acting in the capacity of a Funeral Director or Embalmer.

8. Case No.: 2020065801 - Funeral Establishment

This is a Consumer complaint alleging unprofessional conduct by the Respondent establishment. The Consumer indicated that in August 2020 their sister passed away in Kentucky and was transported to the Respondent establishment. The Consumer states that over a three-week period they contacted the Respondent, informing them that she was the next of kin, and that her sister needed to be transported back to Kentucky. The Consumer states that the Respondent would not release their sister's remains without her paying them.

The Respondent responded to the complaint and indicated the following:

- 1. The Respondent was contacted by the Bowling Green Medical Center indicating that the family requested their services.
- 2. The Consumer then contacted the Respondent indicating that they did not have money and that they wanted their sister sent back to Kentucky.
- 3. The Respondent disputes the claim that they informed the Consumer that they threatened to hold the body until the Consumer paid them.
- 4. The Respondent transported the Consumer's sister back to Kentucky free of charge.

The Consumer provided a rebuttal disputing the Respondent's claims. The Consumer provided documentation regarding their communications with the Respondent.

9. Case No.: 2020067331 - Expired Apprentice Funeral Director Registration

This is a Consumer complaint alleging unprofessional conduct. The Consumer states that they met with the Respondent regarding the purchasing of a headstone for their nephew. Consumer states they paid the Respondent in March 2020 with the remaining balance to be paid in May 2020. In April 2020 the Consumer states the headstone design was finalized. Consumer states that the Respondent was unresponsive to phone calls after the finalization of the marker. Consumer states that the Respondent indicated that the marker would be placed in August 2020; but as of the date of the complaint, the marker had not been placed.

The Respondent has not responded to the complaint. All correspondence with the Respondent was returned as undeliverable.

Legal reached out to the Consumer to follow up but was unsuccessful.

10. Case No.: 2020069641 - Embalmer

This is a complaint submitted by a licensed funeral director alleging unprofessional conduct. Specially, the Complainant alleges that they took over a position from the Respondent at a medical college and noticed that there were multiple un-embalmed bodies left by the Respondent, despite the Respondent listing that the bodies had been embalmed on the death certificates. The Complainant states they alerted the Office of Vital Statistics and amended the death certificates.

The Respondent responded to the complaint and indicated that they were informed they were terminated from the medical college due to a reduction in staff. Because of the termination being effective immediately the Respondent indicated they were unable to complete the embalming process, to which the college was alerted of such. The Respondent states that embalming of cadavers for anatomical donations is unlike a regular embalming and requires more time than normal. Therefore, they were unable to complete the embalming prior to their departure. The Respondent also states that they were not responsible for entering the data on death certificates. Lastly, Respondent states that the college internally investigated the concerns and no basis was found.

The medical college provided a letter indicating that they internally investigated the matter and found that the Respondent did nothing wrong.

11. Case No.: 2020071041 - Funeral Establishment

This is a Consumer complaint alleging unprofessional conduct by the Respondent. Specifically, the Consumer indicated that in or around late July / early August 2020 the Respondent establishment removed the consumer's father's body from the hospital after the Consumer requested an autopsy. Additionally, the Consumer states that the Respondent refused to give them the death certificate, despite the Consumer being next of kin.

The Respondent responded to the complaint and indicated the following:

- 1. That on July 31, 2020 the Respondent received a phone call from the deceased's fiancé regarding the passing of the deceased.
- 2. On that day the hospital called the Respondent regarding the removal of the deceased, and an appointment was made for the removal to occur on August 3, 2020.
- 3. The Respondent states that the Consumer never expressed wanting an autopsy to the Respondent.
- 4. The Respondent denies the allegation that the Consumer was refused a death certificate. The Respondent sates that they informed the Consumer that they would order a death certificate, but they have not heard from the Consumer since.

12. Case No.: 2020092901 - Embalmer

Note: Cases 12 and 13 were considered together.

This complaint was opened based on a 2018 complaint which was previously presented to the Board at its November 13, 2018 meeting as follows: Complainant alleged Respondent embezzled money from a funeral establishment and obtained several credit cards in the funeral home's name, but used them for personal purchases.

A final judgment was entered in the case. The Respondent was found guilty of a class E felony charge of theft greater than \$1,000 but less than \$2,500. The Respondent received a one-year sentence that was suspended to one year of probation supervised by Community Corrections.

Recommendation:

Authorization for a formal hearing. Authorization for suspension of funeral director and embalmer licenses for a period of six calendar months, beginning on the first day of the month following execution of the Order, a civil penalty of \$1,000.00, ten hours of continuing education courses approved by the Board, and successfully pass the Tennessee Laws, Rules, and Regulations Examination via Consent Order. Additionally, the Consent Order shall include that the Respondent cannot work, perform services, or be associated in any manner with a funeral establishment during the suspension period.

Recommendation: Litigation monitoring.

Additionally, the Consent Order shall include that the Respondent cannot work, perform services, or be associated in any manner with a funeral establishment during the suspension period.

Additionally, the Consent Order shall include that the Respondent cannot work, perform services, or be
