RE-PRESENTATION OF CASES

1. Case No.: 2011007122, 2011007123, 2011007121

This case involved unlicensed activity by an individual along with an auto auction allowing an individual (the unlicensed mentioned) to buy motor vehicles for a TN dealer without being a licensed salesperson. Both the individual (with dealer) and auto auction were assessed civil penalties (\$2,500 individual/dealer and \$1,500 auto auction). The auto auction paid the full amount assessed. The dealer has gone out of business and surrendered license. The individual sent a check for \$500 almost a year ago and failed to sign a consent order.

A second motor vehicle dealer was also assessed a \$2,500, which is out of business and license is expired.

This is an attempt to finalize this case due to the inability to contact Respondent's out of business.

Recommendation:

2011007121 - Reduce civil penalty amount to \$500 on part of Respondent individual and dealer (out of business) and Close.

2011007123 – Close. Respondent is out of business. Cannot be found.

2011007122 - Close - Respondent is out of business. Cannot be found.

Commission Action:

2011007121 – Reduce civil penalty amount to \$500 on part of Respondent individual and dealer (out of business) and Close.

2. Case No.: 2012000251
