Legal Report

Corrections to Legal Report- Incorrect numbers typed in Legal report. Case # 60-2011002911, should have been case 2011031871. Case # 77-2011021271, should have been case 2011024291.

92. Case No.: 2012000061

Complainant alleged the vehicle was misrepresented as having a clear title, but according to the contract that the Complainant signed, it shows the disclaimer of the vehicle being wrecked and possibly having a branded title. The contract signed by Complainant included language that stated, "The above vehicle has been wrecked before and may have had frame damage and/or branded title." However, despite this language, Complainant alleged that he was not aware of the salvage title until he received the title from the state with the language, "Actual mileage; Rebuilt vehicle; Anti-Theft Inspection passed". Complainant claimed this was the first he had been made aware of the salvage title on the vehicle.

<u>Recommendation</u>: Present to Commission in an open-ended manner to get the opinion of the Commission as to whether the "Rebuilt" language on the sales contract constitutes sufficient disclosure as to the salvage status.

<u>Review Committee Recommendation:</u> Recommendation is to close with No Violation, as the Commission agreed that the language used by Respondent was sufficient disclosure of "Rebuilt title".
