Summary: Anonymous complaint that a new individual was operating respondent's company in TN without active licensure. Respondent was owned and operated by this new individual's father, however father is deceased. The new individual, the son, owns a PI company in a neighboring state. No evidence respondent, or this other individual, had performed any unlicensed activity in TN.

Summary: Complainant engaged in services from Respondent in August 2019 after Respondent's wife had been receiving harassing e-mails and texts from an unknown person. Complainant alleged that Respondent had failed to render promised results and had not appropriately communicated with him. After multiple cancelled meetings and disagreement between parties complainant terminated contract with respondent.

This is an issue for complaint to pursue in civil court for breach of contract.

#### Application Review – Richard A Brooks

Richard A Brooks is requesting to reinstate his license and to make a new application, but does not want to take the exam. His license expired August 31, 2006, and would like to use his extensive experience in place of the exam.

Richard Brooks Investigations I am Richard A. Brooks from the Jackson, MS area. I am a former licensed private investigator in Tennessee. My TN license was 5839 and it expired August 31, 2006. I am requesting a review and

to be reinstated without retaking the PI exam, which I took many years ago.

I have been a licensed PI consistently since approximately 2001. I have been a civilian law enforcement officer periodically since 1995. I continue work part time as a police officer today in

order to maintain my law enforcement certification. I was an active duty Air Force Security Policeman from 1986-1990.

I have been a licensed PI in Arkansas, Georgia, Indiana, New York, Texas, Louisiana, Alabama, Florida and of course, Tennessee. I have maintained my PI licenses in Texas, Louisiana, Alabama and Florida. As I noted, since 2001, I have been consistently licensed somewhere as a PI. I have taken many PI licensing exams over the years.

I am currently the Past President of the Mississippi Professional Investigators Association. I was the President of the association three times. I have written legislation to license all private investigators in the state of Mississippi. My bill has passed the House but currently sits in the state

Senate where it has been for the past few years. My hope is to eventually pass the bill and obtain

reciprocity with surrounding states like Tennessee.

I am requesting to be reinstated so I can accept cases in Tennessee again. I am approximately 3 hours south of Memphis. I will also continue my efforts to license the state of Mississippi. Richard A. Brooks, CPS, CFI-FTER
