LEGAL REPORT – BENTON MCDONOUGH, ASSISTANT GENERAL COUNCIL

Mr. McDonough advised only one (1) complaint is pending and it is scheduled for a formal hearing at the Council's next meeting in June 2011.

ADMINISTRATIVE REPORT - DONNA HANCOCK, DIRECTOR

Complaint Statistics & Comparison Report – Ms. Hancock presented a report of the complaints open at this time last year compared to the ones currently open.

Budget Report for Fiscal Years 2007-2010 – Ms. Hancock presented a copy of the budget summary for fiscal years 2007 – 2010 for the Council's review. She gave an oral report of the expenditures and revenues for fiscal year 2009/2010 and advised that the year closed with a positive balance of \$96,164.

Quarterly Provider Fee Report – Per the Council's request at the December 2010 meeting, Ms. Hancock presented examples of quarterly reports received for various probation firms for comparison. The smaller firm reported 435 probationers; the medium size firm reported 705 probationers; and the larger firm reported 2859 probationers for the same quarter.

NEW BUSINESS / UNFINISHED BUSINESS:

It was agreed at Chairman Craft's request that he submit a copy of the fiscal report Ms. Hancock presented to the oversight committee for their reference.

In response to an inquiry from Chairman Craft, Ms. Hancock advised that she is not aware of the outcome of the Council's request for proposed legislation to allow them to cancel meetings at their discretion.
